**SPECIAL CEREMONY HONORING RETIRING MEMBERS**

At 10:54 a.m., a special ceremony was convened to honor Members retiring from the California State Assembly.

The following resolution was read:

**House Resolution No. 79**

By Assembly Member Villaraigosa

*Relative to commending the Honorable Jan Goldsmith.*

WHEREAS, The tenure of the Honorable Jan Goldsmith with the California State Assembly is drawing to a close following six years of exemplary service, and it is appropriate at this time to highlight the many achievements of his illustrious tenure and to extend to him the highest commendation; and

WHEREAS, The former Mayor of Poway, Jan Goldsmith was elected to the Assembly in 1992 and reelected in 1994 and 1996, as the representative of the 75th Assembly District, which encompasses parts of San Diego and Escondido, along with the Cities of Poway and Santee, the communities of Campo, Tecate, Alpine, Borrego Springs, Lakeside, Ramona, Rancho San Diego, and parts of Casa de Oro and Spring Valley; and

WHEREAS, During his first term, Assembly Member Goldsmith served as Freshman Republican Leader; he also has brought distinction to himself as Assistant Republican Leader, Majority Floor Leader, member of the powerful Assembly Rules Committee, Chair of the Banking and Finance Committee, the Subcommittee on Juvenile Justice, and the Subcommittee on Border Crime, and Vice Chair of the Public Safety Committee; and

WHEREAS, Most recently, he has provided leadership as a member of the Education Committee, the Human Services Committee, the Select Committee on California-Mexico Affairs, the Select Committee on School Safety, and the Joint Committee on Prison Construction and Operations; and

WHEREAS, Best known for his leadership in fighting fraud, government waste, over-regulation, and excessive taxation, Assembly Member Goldsmith brought public attention to fraudulent practices involving education, welfare, and Medi-Cal, saving California taxpayers millions of dollars, and he was named Legislator of the Year by the Law Enforcement Alliance of America; and

WHEREAS, A true deficit hawk, he authored Assembly Constitutional Amendment No. 1, a balanced budget amendment for California, and, in addition to fighting deficit spending, has strived for tax relief and opposed artificial economic controls; and

WHEREAS, Assembly Member Goldsmith has fought hard for improvements in the areas of child abuse, foster care, and children's health; calling for an end to racial divisions in government programs, he won passage of landmark legislation to eliminate the ban on trans-racial adoption and foster care placement, and he authored legislation to eliminate the archaic requirement that a medical professional be present to administer the blood-glucose "finger prick" test on children with diabetes; and

WHEREAS, In recognition of his tireless devotion to helping children, he was given "A True Friend of Children" award by the Foster Parents of Los Angeles, and he was named "Legislator of the Year" by

the California State Foster Parent Association, received a Distinguished Service in Advocacy award from the American Diabetes Association, and the California Children's Lobby honored him with their "Super Nova" award as the brightest star for children; and

WHEREAS, He completed his undergraduate studies at the American University in Washington, D.C., and is a magna cum laude graduate of the University of San Diego Law School; and

WHEREAS, Assembly Member Goldsmith and his wife, Christine, are the parents of three children, Brett, Scott, and Jennifer; and

WHEREAS, Through his public service activities, he has made a significant impact on the people of the 75th Assembly District and throughout the state, and he will be very much missed by those individuals with whom he has been associated; now, therefore, be it

*Resolved by the Assembly of the State of California*, That they express their commendations and appreciation to their colleague, the Honorable Jan Goldsmith, for his outstanding record of dedicated service to his constituents and to all of the people of California, and convey to him best wishes for every success in his future endeavors.
