Assembly Member Shelley was granted unanimous consent that Joint Rule 62(a) be waived for the purpose of setting Senate Bills Nos. 1757 and 1714 for hearing in the Committee on Utilities and Commerce.

ANNOUNCEMENTS

Acting Speaker Keeley announced the following:

All bills not taken up on this day would be recorded as "Pass on File" and those measures that are passed on file on two successive days would be placed upon the inactive file pursuant to the Rules;

that by mutual agreement of leadership, debate would be limited today to 5 minutes to open debate and two minutes for all other debate; and that all concurrences on the unfinished business file would be deemed eligible for consideration, provided the analyses have been distributed.

Parliamentary Inquiry

Assembly Member McClintock arose to the following parliamentary inquiry:

Did the Presiding Officer announce that although controversial measures have been deferred to the final days of session, leadership has agreed to limit debate on the important issues before the Body?

Reply by Acting Speaker Keeley

The Acting Speaker replied that the mutual agreement by the leadership is an attempt to expedite the business of the House in the final 3 days of the legislative session and that such agreement is to limit the length of the debate and not a limit on the number of Members who wish to be recognized to debate.

Does the attempt to limit debate apply to the education bond measure and the measure impacting a ballot proposition on today's File?

Reply by Acting Speaker Keeley

The Acting Speaker replied that it was agreed by leadership of both Caucuses that debate would be limited as he had announced.

Unanimous Consent Withheld

Assembly Member McClintock withheld unanimous consent on a request to limit debate on measures on today's file.

Announcement by Assembly Member Leonard

Assembly Member Leonard announced that he did not object to a limitation of debate on noncontroversial measures on today's file and requested that the Presiding Officer permit Members to complete their debate on controversial measures.

Dear Mr. Wilson: I respectfully request that this letter be printed in the Assembly Journal for purposes of clarifying the intent of my Assembly Bill 1024. This measure directs the California Commission on Teacher Credentialing (CCTC) to adopt regulations that provide for the acquisition of significant preparation in teaching dance or theatre by holders of single subject credentials in any of the current credentials. The CCTC assures me that the preparation requirements for those voluntarily seeking dance and/or theatre concentrations would only be obtainable within the appropriate and relevant single subject credentials presently offered.

I introduced AB 1024 to adopt recommendations as a result of SCR 31, Chapter 128, Statutes of 1994. The report issued pursuant to SCR 31 by the CCTC is entitled *The Qualifications of Dance and Theater Teachers in California Schools: State Policy Issues and Options*. In its current form, AB 1024 reflects the options from the report that the Office of Child Development and Education and the CCTC believed were important first steps to take to improve the quality of theater and dance teaching in the state.
