Members of the Assembly: As directed by the Joint Legislative Audit Committee (Audit Committee), my office conducted an audit of tropical forest-risk commodities (forest-risk commodities). Forest-risk commodities, such as beef, soy, and palm oil, are raw materials whose production in the tropics may be associated with deforestation; however, the production of these commodities does not always result in tropical deforestation. In general, we determined that the State could take some steps to better ensure that it does not contribute to tropical deforestation, but it is challenging to determine the extent of the State's contribution.

Using available data, we determined that the State procured more than \$82 million in forest-risk commodities in 2023. However, because of the complexity of supply chains and the lack of data available for determining whether a product contains forest-risk commodities, that number could be much higher or lower. Further, the State does not have supply chain information to determine whether its procurements actually contributed to tropical deforestation. We found that the State could expand its policies to reduce the risk that it is inadvertently contributing to tropical deforestation.

Although the California Transparency in Supply Chains Act (Transparency Act) does not relate to tropical deforestation, the Audit Committee directed us to assess the State’s implementation and enforcement of the Act. We found that the State could expand the Transparency Act to incorporate other policy priorities—such as tropical deforestation—but the State would first need to address weaknesses in the Act. For example, the Franchise Tax Board (FTB) must rely on limited information from tax returns when creating a list of companies subject to the Transparency Act each year, and those lists are likely inaccurate and incomplete. In reviewing FTB’s most recent list, we found that only 10 percent of the companies we selected were in compliance with the Act. Finally, the Office of the Attorney General is responsible for enforcing the terms of the Act, including seeking injunctions against businesses that do not comply, but it has not actively determined compliance with the Transparency Act since 2016.

Dear Ms. Parker: I am writing to request the following letter be entered into the Assembly Journal:

I have authored AB 828, which would pause the collection of fees and fines by Groundwater Sustainability Agencies from managed wetlands and small community water systems serving a disadvantaged community pending approval of a groundwater sustainability plan submitted after January 1, 2025.

It is my intent that this pause would apply only to small community water systems whose entire service area qualifies as a disadvantaged community according to Water Code 79505.5(a). This statute was implemented to provide financial assistance to public water systems and has been interpreted for the past two decades as referencing the median household income of the entire service area of a public water system. This has been the practice of the Drinking Water Program, first at the Department of Public Health, and since 2014, at the State Water Board.

The statutes of the Drinking Water Program in the Health and Safety Code provide a more explicit explanation for how this statute is applied:

Health and Safety Code, Section 116275 (aa) “Disadvantaged community” means the entire service area of a community water system, or a community therein, in which the median household income is less than 80 percent of the statewide annual median household income level.

This bill assumes the common interpretation of this statute.

Dear Ms. Parker: I have authored AB 2745 to protect all agriculture in the State of California. Every agricultural operation in this state has different challenges and goals, however they all have one particular challenge in common: pests.

This measure was drafted to protect the agricultural community from negligent properties that do not even attempt to address the challenges faced on their land. Whether a farm uses pesticides or not, an infestation can destroy an entire yield, and the livelihood of the operator as a result. It is my belief that every farm in this State, no matter their method of farming, should be protected against bad actors that negligently put their livelihood and way of life in danger.

AB 2745 was carefully crafted with intentionally specific language to ensure that farmers can address the challenges they face in a way that aligns with their operational goals. If a farm wants to pursue an organic or integrative approach to agriculture, this measure makes that possible. The only requirement that this measure places on property owners is that they take good faith action to address the challenge at hand. Whether that action is through organic means or other, this measure allows a property to work hand-in-hand with Agricultural Commissioners to solve the problem of pest infestations. **It is not my intent for this legislation to force pesticide use upon any property.**

This State has taken the initiative to champion organic, integrative, and regenerative agriculture, and my intent is to allow those practices to flourish in a State that holds those who disregard their way of life and livelihoods accountable.
