PRAYER

Upon invitation of Speaker pro Tempore Lowenthal, the following prayer was offered by Reverend Bob Oshita:

While a student in Japan over 50 years ago, I was able to visit the home where my mother grew up. I stayed in mom's family home that had a traditional thatched roof. It was on a hillside where they farmed terraced rice paddies about 10 miles from Hiroshima city center. My uncle Akira took me to the Peace Memorial Museum, but he asked me to go in alone. He was an Atomic Bomb survivor and needed no reminders. Hours later, we drove home in silence. Once home, my Auntie Toyoko asked me how it was. Seeing my look of disbelief, she smiled and said, "What you saw today was nothing!" Later, they both shared what they witnessed that day . . . and in the days that followed.

The morning of the atomic bombing, they were fortunately inside when they heard the explosion that rocked the house. They went outside to see the mushroom cloud rising over the city. Their innocent eyes had never seen such a cloud; and they remarked, "Ahh! It's so beautiful!" Then they noticed that in just one small area, their roof was on fire. Auntie said that looking up the hill, every roof that dotted the hillside was on fire the exact same amount; nothing else, just the thatched roofs. It was so impossibly absurd, they initially laughed, as they rushed to put out the small fire. A flash of over 7,000 degrees Fahrenheit had ignited fires well beyond the blast. They were fortunate to have been inside. Only later did they realize the horrific destruction, loss and pain that mushroom cloud represented.

One of my teachers, who survived "the bomb," also commented on how beautiful the mushroom cloud was. Eighty-one years ago, this month, my family in Hiroshima were among the last people who would have such innocent eyes to see beauty in the bomb. That day changed the world forever.

With our wisdom eyes open, we know that there is no beauty in a mushroom cloud . . . and there are no winners in a nuclear war.

Namo Amida Butsu—Let us live with kindness and gratitude beyond words.
