Dear Mr. Wilson: As the author of AB 333, I am writing to request the inclusion of this letter into the Assembly Daily Journal:

AB 333 addresses a number of technical issues associated with the Medical Waste Management Act administered by the California Department of Public Health (CDPH). My office and the sponsors negotiated a number of amendments with the CDPH last week which were amended into the measure. The purpose of this letter is to provide clarity as to the intent and interpretation of the bill as it relates to the stakeholder group and report to the Legislature on the interaction of federal and state standards related to the transportation of medical waste. The reporting requirement contained in Section 117605 (c) expires on January 1, 2016 or upon submission of the report. It is Legislative Counsel's opinion and my intent that the requirement for the Department of Public Health to convene a stakeholder group for purposes of developing the report also sunset as of this date. As it was explained to me, the action of the stakeholder group was for the purpose of the report, hence once the expiration date or the submission of the report occurs, the stakeholder group also expires.

Dear Mr. E. Dotson Wilson: I respectfully submit this letter to the Journal to document the legislative intent of Assembly Bill (AB) 1439 which I authored, passed by the legislature in 2014.

AB 1439 makes internet gambling sweepstakes at internet cafés an unfair business practice. The bill is intended to target operators of these illegal operations as well as suppliers of products and technology used for these illegal operations. The bill is not intended to affect legal gambling or regulated lawful sweepstakes.

Lack of clarity in the California Penal Code has permitted illegal internet gambling sweepstakes to operate, in business establishments, and evade law enforcement. These internet gambling sweepstakes operations typically establish themselves in an economically depressed area, accrue hundreds of thousands of dollars through illegal gambling and only close when forced by law enforcement for violations. Often, these illegal gambling cafés will then re-open in a new location, threatening to negatively impact another neighborhood in the community.

This legislation aims to bring clarity to the California Business and Professions Code to prohibit these activities and provide local authorities with the necessary enforcement tools to regain local control of the public safety issues that arise because of illegal internet gambling sweepstakes.

Untested rape kits mean lost opportunities to develop DNA profiles, search for matches, link cold cases, prosecute offenders, and bring resolution to rape victims. Delays in testing can also preclude criminal charges from ever being filed against rapists who are identified long after they commit their crimes.

It was my intent in authoring AB 1517 to further the purpose of Proposition 69, adopted by California's voters in 2004, which recognized in its findings that law enforcement "should be able to use the DNA Database and Data Bank Program to substantially reduce the number of unsolved crimes; to help stop serial crime by quickly comparing DNA profiles of qualifying persons and evidence samples with as many investigations and cases as necessary to solve crime and apprehend perpetrators; to exonerate persons wrongly suspected or accused of crime; and to identify human remains."

It was also my intent in authoring AB 1517 to further the finding in Proposition 69 that the "state has a compelling interest in the accurate identification of criminal offenders, and DNA testing at the earliest stages of criminal proceedings for felony offenses will help thwart criminal perpetrators from concealing their identities and thus prevent time-consuming and expensive investigations of innocent persons."

Funding from Proposition 69 can only be used for certain purposes, including the following:

... to local sheriff, police, district attorney, and regional state crime laboratories for expenditures and administrative costs made or incurred in connection with the processing, analysis, tracking, and storage of DNA crime scene samples from cases in which DNA evidence would be useful in identifying or prosecuting suspects, including the procurement of equipment and software for the processing, analysis, tracking, and storage of DNA crime scene samples from unsolved cases. (Gov. Code, sec. 76104.6, subd. (b)(3).)

Because the funds provided by Proposition 69 are intended to pay for the costs of processing DNA evidence, if available, it is my intent in authoring AB 1517 that any additional costs incurred by county crime labs for processing rape kits in compliance with the guidelines in AB 1517 should be addressed in a manner that is consistent with the intent of Proposition 69.

### Legislative Intent—Assembly Bill No. 1751

Dear Mr. Wilson: As the author of Assembly Bill 1751, I am requesting the inclusion of my statement to clarify the intent of the bill as it relates to Continuing Care Retirement Communities (CCRC) into the Assembly Daily Journal.

AB 1751 requires the governing body of all CCRC providers to accept at least one resident, or 2 residents for a governing body with 21 or more members, from the continuing care retirement community or communities it operates to participate as voting members of the provider's governing body.

AB 1751 provides an alternative to this requirement for a provider that is a sole proprietorship, general partnership, limited partnership, limited liability company, or closely held corporation. These companies may elect, in lieu of a voting resident, to appoint a select committee of the company's members to meet with the resident association or a resident-elected committee semiannually and at least 60 days prior to any financial or administrative changes, including but not limited to, any proposed increase in monthly fees, indebtedness of the provider, expansion or contraction of the community, or other changes that would result in a budget variance, or any policies, programs, or services that would materially change the operation or environment of the community.

This alternative is intended to provide residents with an opportunity to give input on policy and financial decisions that are considered by the provider's governing body. A decision that materially changes the operation or environment of the community, as referenced by AB 1751, is not intended to include routine or day-to-day operational decisions that do not require the consideration of the provider's governing body. Examples include, but are not limited to: routine maintenance and repair; resident requested changes to living units; changes required to comply with applicable laws or regulations; changes needed to address health and safety concerns; personnel decisions; and facility security.

Dear Mr. Wilson: I respectfully submit this letter to the Assembly Journal to provide clarification on the intent of Assembly Bill (AB) 1873 relative to special mail ballot elections in San Diego County.

AB 1873 seeks to explore options for counties to expand voter participation in traditionally low turnout special elections by authorizing a mail ballot pilot program to conduct special vacancy elections for Congress and the Legislature as primarily vote-by-mail elections, subject to certain conditions. As a result of drafting errors, AB 1873 does not reflect the intent of the bill in three aspects, which are described below.

Firstly, regarding the bilingual poll workers at polling places on Election Day (Section 4000.5(a)(6)(D)), the intent of the author was for AB 1873 to spell out what the County would be required to do in two separate subparagraphs, with one paragraph articulating an unqualified requirement that bilingual poll workers required under federal law be present at polling places on Election Day, and another paragraph requiring the jurisdiction to make reasonable efforts to recruit bilingual poll workers required under state law.

Secondly, regarding the voter education workshops required to be conducted in an effort to ensure sufficient voter education about the primarily vote-by-mail elections found in Sections 4000.5(a)(8)(A)(ii) and 4000.5(a)(8)(A)(iv), while not these subparagraphs use the more generic term "voter education program," the author's intent is for in-person voter education workshops to be conducted.

Thirdly, the post-election reporting requirements of the County in Section 4000.5(i)(1) are not intended to be limited exclusively to the topic of language accessibility. The phrase "as it relates to the languages required under the federal Voting Rights Act of 1965" in this section was intended to be left out, so as not to be thought to qualify any of the language preceding it.

#### Legislative Intent—Assembly Bill No. 2124

Dear Mr. Wilson: I am submitting this letter to the Assembly Daily Journal to clarify my intent regarding AB 2124, relative to a deferral of sentencing pilot program in Los Angeles County.

Section 1001.96 states that a defendant who successfully completes any terms, conditions or programs ordered by the court may indicate in response to any question concerning his or her prior criminal record that he or she was not arrested or granted deferred entry of judgment for the offense, except as specified. It is my intent that nothing herein relieves a defendant from disclosing his or her arrest or deferral as required under other applicable law.

Section 1001.98 precludes defendants who are charged with a number of explicitly specified crimes from being diverted. It is my intent that this section be clarified, as necessary, to specify other interrelated, serious misdemeanor offenses.

Section 1001.98 (c) states that a defendant shall not be eligible for deferral of sentencing if he or she has previously had a sentenced deferred pursuant to this bill or any other provision of law. It is my intent that the Los Angeles Superior Court work with prosecutors and relevant stakeholders to establish the means to document those defendants who have been deferred, such that they cannot be deferred a second time under the bill's provisions.

Dear Mr. Wilson: I am submitting this letter to the Assembly Daily Journal regarding AB 2293 in order to clarify how excess insurance coverage, outlined in Section 5433 (c)(2), is intended to work when a driver is logged on simultaneously to multiple online-enabled applications or platforms belonging to different transportation network companies.

AB 2293 requires the transportation network company to also maintain insurance that provides excess insurance coverage, for the transportation network company and the driver, of at least two hundred thousand dollars (\$200,000) per occurrence to cover any liability arising from a participating driver using a vehicle in connection with a transportation network company's online-enabled application or platform.

It is my intent that when more than one transportation network company provides excess insurance coverage as outlined in Section 5433 (c)(2), the insurers providing such excess insurance coverage shall share the cost relating to any claims against that excess insurance coverage for any accident based on the contract terms or, in the absence of contract terms addressing this issue, on a pro rata basis. It is further my intent that if there are multiple excess insurance coverage policies, as described in Section 5433 (c)(2), the policies will not be stacked.

Legislative Intent—Assembly Bill No. 4

Dear Mr. Wilson: The purpose of this letter is to express my intent as the author of Assembly Bill 4, known as the TRUST Act.

The bill sets conditions that must be met before an individual may be detained by a law enforcement official on the basis of an immigration hold, also known as an "immigration detainer."

Since the intent of the bill is to restore trust between law enforcement and the communities they serve by limiting the situations in which individuals may be detained on the basis of immigration holds, it is my intent that wherever the bill language is ambiguous as to detention authority, detention is not authorized. Below, I discuss my intent with respect to specific provisions of the bill.

Detention on the basis of a criminal conviction: Section 7282.5(a)(2) of the bill permits detention only if an "individual has been convicted of a felony punishable by imprisonment in the state prison." It is my intent that this provision incorporates realignment standards. Thus, it applies only if the felony would be punishable in state prison as of October 5, 2013, the date of the TRUST Act's enactment. This is true regardless of the date of conviction.

Section 7282.5(a)(3) of the bill does not permit detention of an individual who has been convicted only of a "straight misdemeanor"— that is, a misdemeanor that can be charged only as a misdemeanor and

not as a felony. Although several "straight misdemeanors" are enumerated in sub-sections (a)(3)(A)–(AE), convictions for these offenses do not authorize detention on the basis of an immigration hold. That is because these offenses are not "punishable as either a misdemeanor or a felony" as required under Section 7282.5(a)(3). The enumerated straight misdemeanors that do not authorize detention under Section 7282.5(a)(3) are as follows: Penal Code §§ 240; 242; 647.6(a) (first offense); 273a(b); 463(c); 74; 417(a) and (d); 26100(a); 404.6(b); 368(c); 653.23.

Finally, in Section 7282.5(a)(3)(M) of the bill, I intend the word "felony" to modify the entire clause. Accordingly, only convictions for felony possession, felony sale, felony distribution, felony manufacture, or felony trafficking of controlled substances are included. Convictions for misdemeanors or wobbler offenses are outside the scope of § 7282.5(a)(3)(M).

*Definition of conviction:* It is my intent that the definition of conviction in § 7282(a) applies only to serious and violent felony convictions. The definition does not limit the bill's application to individuals convicted of non-serious and/or non-violent offenses. Regardless of the type of offense, any conviction that has been expunged or dismissed under Cal. Penal Code § 1203.4 does not constitute a conviction under the bill.

Detention on the basis of a pending criminal charge: Section 7282.5(a)(5) of the bill permits detention on the basis of an immigration hold only after a magistrate judge has made a probable cause determination pursuant to California Penal Code § 872. An individual who is awaiting, but has not yet received, a § 872 probable cause determination does not fall within the scope of Section 7282.5(a)(5). Section 7282.5(a)(5) also does not permit the detention of an individual who has waived his or her right to a § 872 probable cause determination because such a waiver does not constitute a probable cause finding by a judge. Individuals in these situations may be eligible for release on bail or otherwise. Because these individuals may not be detained on immigration holds, the existence of a hold should not affect their eligibility for release.

In addition, Section 7282.5(a)(5) does not permit detention for individuals who have been charged with, but not convicted of, felony driving under the influence. Pursuant to Section 7282.5(a)(3)(G), the felony offense of driving under the influence may justify detention on the basis of an immigration hold only where there has been a conviction.

Applicability to juveniles: I intend the bill's protections against immigration hold requests to apply to juveniles booked and held in juvenile detention facilities. However, I do not intend the word "conviction" as used in the bill to include juvenile adjudications that result in a sustained petition. The one exception is for a juvenile adjudication for an offense that was committed when the juvenile was sixteen or older and that is listed in Welfare & Institutions Code § 707(b). See PC § 667(d)(3) (defining serious and violent felonies with respect to juvenile adjudications). It is my intent that such a juvenile adjudication constitutes a conviction under the bill, but these are the only cases in which a juvenile adjudication can serve as the basis for responding to an immigration hold request. Interaction with other laws and policies: This bill does not permit any detention on the basis of an immigration hold where such detention would otherwise violate federal, state, or local laws or local policies, including where such detention would violate the Fourth Amendment of the United States Constitution as discussed in *Miranda-Olivares v. Clackamas County*, No. 3:12-cv-02317 (D. Ore. April 11, 2014). The bill creates a floor, not a ceiling. Other bodies, including local agencies, are free to pass policies that go further in limiting compliance with immigration holds; and in these cases, the local policies will control.
