Legislative Intent—Senate Bill No. 481

Re: SB 481 (Speier)

Dear Mr. Wilson: I have introduced SB 481 in response to two actions prosecuted by local district attorneys and an undercover expose produced by a bay area television station involving situations where automobile dealers quoted or actually sold advertised vehicles to unsuspecting customers at prices that greatly exceeded their advertised price.

Although it is currently unlawful for a dealer to fail to sell a vehicle at an advertised total price during the time period for which the advertisement applies, there is no current requirement that the advertised price be posted on either the vehicle or at the dealer's business premises. The lack of a posting requirement has lead to consumer confusion relative to which vehicles in a dealer's inventory are the subject of a dealer's advertisements.

I have introduced SB 481 to remedy this problem and assist consumers when shopping for a new or used vehicle by requiring dealers to post advertised prices in one of several manners. A dealer may post the advertised price on or in the advertised vehicle or post a list of its advertised vehicles in a conspicuous location in the showroom. It is intended that the showroom posting requirement may be fulfilled by clearly and conspicuously posting a copy of the advertised vehicles on a bulletin board, computer monitor, or other location that is easily accessible by prospective purchasers.

SB 481 is also intended to codify existing regulations which require that an advertised vehicle must be sold at the total advertised price to any consumer, regardless of whether the consumer has knowledge of the advertisement or the advertised total price. It is also intended that specific vehicles advertised for sale on an Internet website that is accessible by the public be subject to the provisions of subdivision (e) of Vehicle Code Section 11713.1. However, website and other types of media advertisements that do not display specific prices for advertised vehicles or advertisements that display no prices but invite consumers to request individual price quotes via e-mail or other direct one-on-one communications, are not covered.

SB 481 is also intended to clarify that if a dealer advertises a specific vehicle for sale, the advertisement must identify the vehicle by either its license plate number or that portion of its vehicle identification number (VIN) that distinguishes the vehicle from all other vehicles of the same make, model, model-year, and type. For example, if a dealer

ran an advertisement that states "1996 Ford Mustang \$10,000", the dealer would be required to include the license plate number or distinguishing portion of the VIN in the advertisement and post the \$10,000 sale price on the vehicle or list the advertised price in the dealer's showroom during the period the vehicle is advertised at that price. However, advertisements that offer for sale a class of new vehicles in a dealer's inventory consisting of five or more vehicles that are all of the same make, model, model-year, and type, are not required to contain the VIN for each vehicle in the class and no price posting is required. For example, if a Toyota dealer advertised "\$2,500 off MSRP all Camry LEs in Stock" and had five or more of those vehicles in inventory, the dealer would not be required to include the VIN for each Camry LE in the advertisement or post the advertised price on the vehicles or in the showroom.

Finally, federal law requires each vehicle manufacturer to affix a window sticker (Monroney Sticker) to the windshield or side window of each new motor vehicle prior to its delivery to a dealer (see 15 U.S.C. 1232). The Monroney Sticker is required to contain specified information, including the make, model, VIN, final assembly point, name and location of dealer to whom the vehicle is to be delivered and, the retail price of vehicle suggested by the manufacturer (MSRP). As displayed on a new vehicle pursuant to federal law or as listed on a website or other advertisement for information purposes, the MSRP is nothing more than the manufacturer's suggested retail price and is not reflective of a dealer's asking price or a dealer's advertised price. However, if a dealer utilizes MSRP in an advertisement as a benchmark for determining the dealer's specific asking price (\$2,500 off MSRP on All Chevy Tahoes—this weekend only) or publishes an advertisement that infers or implies that a new vehicle will be sold for MSRP, any such vehicle has been advertised at a specified dealer price that must be honored for the duration of any time period specified in the advertisement.
