Dear Senators Atkins and Grove, and Assembly Members Rendon and Waldron: The Department of Human Resources (CalHR) reached new Tentative Agreements with SEIU Local 1000 representing Bargaining Units (BU): 1—Administrative, Financial and Staff Services, BU 3—Professional Educators and Librarians, BU 4—Office and Allied, BU 11—Engineering and Scientific Technicians, BU 14—Printing Trades, BU 15—Allied Services, BU 17—Registered Nurses, BU 20—Medical and Social Services, and BU 21—Education Consultants and Library employees. Upon approval of the Legislature and the Governor, and ratification by the membership, the agreements will be effective January 2, 2020 through June 30, 2023.

These agreements roll over language from past agreements and the attached summary highlights provisions with significant changes. In addition, the state and SEIU Local 1000 have agreed to provide members who pay for health care coverage a \$260.00 increase to offset the cost of health care.

Members will also receive a two point five percent (2.5%) General Salary Increase (GSI), effective July 1, 2020, a two percent (2.0%) GSI, effective July 1, 2021, and another two point five percent (2.5%) GSI, effective July 1, 2022.

In accordance with Government Code sections 3517.5, 19829.5, and Senate Rule 29.4, I am forwarding copies of these agreements, including legislative and fiscal summaries. The Legislative Analyst will be forwarded a copy for analysis, and the Secretary of the Senate and the Clerk of the Assembly will be forwarded copies to note them as available for review in the Daily Journals.

Dear Mr. Wilson: This letter to the journal clarifies my intention of the application of AB 1294. In furtherance of AB 1439 (chaptered 2014), the provisions of AB 1294 are intended to expand the definition of “criminal profiteering activity” to include various gambling device statutes in California’s Penal Code in order to assist law enforcement in combatting illegal gambling operations such as sweepstakes cafes and arcade-style gambling machines. AB 1294 is not intended to render unlawful or restrict otherwise lawful games and methods approved by the Bureau of Gambling Control and used by a gambling enterprise licensed under the Gambling Control Act.

I appreciate the opportunity to state the intent of these statutory changes.
