Dear Mr. Wilson: This letter is to clarify the intent of my bill, AB 1620 relating to hazard waste materials and subpoena.

The investigations of hazardous materials accidents and any examination conducted by a county health officer or administering agency upon delegation from the board of supervisors, as authorized in AB 1620, is subject to the attorney-client privilege as specified in the Evidence Code.

In the Senate Committee on Environmental Quality, I agreed to an author's amendment striking language concerning this privilege that was unnecessary and redundant. The Evidence Code concludes that the attorney-client privilege applies to all types of investigations, including the type of investigation authorized by this bill, and that the bill does nothing to allow a breach of the privilege. Consequently, this amendment did not make a substantive change to the bill.
