Dear Mr. Wilson: This letter to the Journal serves as a clarification to my bill, AB 1511. I want to clarify that AB 1511 is not intended to in any way limit the Santa Clara Valley Water District's power under Section 21162 of the Public Contracts Code to utilize the design-build bidding process for its 15-year flood program, that includes levees, and for building and/or upgrading its water treatment plant facilities.

With the signing of AB 674 (Dutra) in 2001, Section 21162 of the Public Contract Code was created thus granting the Santa Clara Valley Water District the authority to utilize the procedures described in Section 20133 of that Code for its building construction contracts. AB 674 was approved by the Senate on a 40–0 vote and by the Assembly on a 72–1 vote. The consultant analyses prepared for the Committee and Floor votes made clear that in approving AB 674, the Legislature was authorizing the District to utilize the design-build bidding procedures for its flood program and water treatment plants.

AB 1511 will change the procedures described in Section 20133 of the Public Contract Code that counties must follow when using the design-build bidding process and the Santa Clara Valley Water District must follow those changed procedures as well. But AB 1511 is not intended to affect the types of projects for which the District may utilize design build procedures under Section 21162 of the Public Contracts Code.
