Dear Mr. Wilson: On July 2, 2012, the California State Assembly passed Assembly Bill 278 and Senate Bill 900. Both bills were Chaptered by the Secretary of State on July 11, 2012, as Chapter 86 and Chapter 87, Statutes of 2012, respectively. I am providing this letter to the Journal to clarify the intent of those bills.

Under existing law, pursuant to Civil Code Section 2924(b), trustees do not have liability for any good faith error when relying on information provided by the beneficiary regarding the nature and amount of a default. Similarly, the conference committee amendments were not intended to impose liability on an entity that records documents at the direction of a trustee, substitute trustee, or beneficiary who is acting within the scope of authority designated by the holder of the beneficial interest and where the entity is carrying out its recording duties in good faith in the normal course of their activity.

AB 491 will permit cardiac catheterization procedures to be performed in an appropriately equipped and staffed outpatient setting that is on the hospital campus. The procedure will be performed under the direction of a cardiologist, and the medical staff must approve all hospital policies related to the procedures as stated in the bill.

The intent behind this bill is to ensure that medical staff oversight and applicable regulations shall address patient selection based on the operating cardiologist's professional medical judgment, which may include, but is not limited to, consideration of the patient's risk, and the patient's overall health status, to ensure that high risk patients receive treatment in the inpatient setting.

Legislative Intent—Assembly Bill No. 837

Dear Mr. Wilson: Assembly Bill 837, of which I am the author, would require a manufacturer or supplier making an environmental claim relating to the recycled content of a plastic food container, as defined, to maintain information and documentation in support of such a claim. The bill would also require such a manufacturer or supplier to furnish this information, upon request, to any member of the public or to provide the information by furnishing a link to a document on its Internet web site.

The definition of "plastic food container" within AB 837 means a product that includes a tray, clamshell container, or other receptacle that is used, or intended to be used, to hold food. It is not my intention that this definition encompass bottled water that is regulated as a packaged food product in California and defined by the California Department of Public Health, California Health and Safety Code for Bottled, Vended, Hauled, and Processed Water: Chapter 5, Article 12, Section 111070.

Dear Mr. Wilson: The purpose of this letter is to express my intent as the author of Assembly Bill 889.

The bill requires the Department of Industrial Relations (DIR) to adopt regulations to implement and enforce AB 889 under its plenary authority pursuant to the Labor Code, including its authority under Section 50.5 to foster, promote, and develop the welfare of the wage earners of California and to improve their working conditions.

In proposing the promulgation of regulations addressing meal and rest periods in Section 1451(b)(2), it is my intent that such regulations provide for daily flexibility in the scheduling of meal and rest periods.

It is the intent of this that promulgated regulations, addressing "meal and rest period," that such regulations provide for daily flexibility in the scheduling of meal and rest period, and that such regulations also call for compensation for such "meal and rest period," if such "meal and rest period" is not taken.

In proposing the definitional exemptions in section 1450, the bill is not intended to eliminate rights that any employee currently has under Industrial Welfare Commission Wage Order 15-2001. All such Wage Order 15-2001 protections shall remain fully enforceable. The bill similarly is not intended to eliminate any rights that employees working in a private household currently have under Industrial Wage Commission Orders 4-2001 or 5-2001, if their employment is covered by those wage orders.

Since the intent of the bill is to rectify historical exclusions, in proposing Section 1451(c), which provides that DIR may apply the provisions of Industrial Welfare Commission Wage Order 15 to domestic work employees, my intent is to ensure that the working conditions of domestic work employees are improved and are not in any way diminished. My intent in requiring DIR to adopt regulations in Section 1451 is to ensure overtime and meal and rest period protections are implemented for personal attendants, who are defined in IWC Wage Order 15-2001, Section 2(j), and are currently excluded from those protections; and appropriate uninterrupted sleep periods and rules regarding compensation for interruptions.

Finally, in regard to the scope of domestic work, my intent is that casual babysitters over the age of 18 not be covered by regulations promulgated pursuant to this legislation.

Legislative Intent—Senate Bill No. 1456

Dear Mr. Wilson: As principal co-author of Senate Bill 1456 (Lowenthal) and the Assembly Higher Education Committee Chair when SB 1456 was heard in the Assembly Higher Education Committee, I respectfully submit this letter to be printed in the Assembly Journal in order to provide clarification on the intent of SB 1456 and provide guidance on its implementation if signed by the Governor.

Senate Bill 1456 establishes new academic and progress standards to be met by students attending the California Community Colleges (CCC) in order to retain a Board of Governor's fee waiver. SB 1456 also establishes new requirements to be met in order for community college districts to receive matriculation funds.

Previous versions of this measure provided specificity designed to ensure that students who may be in jeopardy of losing their fee waiver eligibility are provided with adequate notice to improve their situation and meet the minimum academic and progress standards established by the CCC Board of Governors. I, like my colleagues in the Legislature, share the concern that students be provided timely notification of their failure to meet the standards. Students must have a reasonable opportunity to remedy deficiencies and thus not lose their fee waiver eligibility.

Specifically, any new standards adopted by the CCC Board of Governors would not go into effect for at least a year from the date of their adoption. It is critical that students who do not meet the minimum

academic and progress standards or those on academic or progress probation be immediately notified at the time the new standards are adopted so these students have the time to remedy any deficiencies. In addition, once new standards are in effect, it is critical that students be individually provided notice no later than the start of the academic term before the loss of fee waiver eligibility so they have sufficient time to remedy deficiencies.

It is my understanding that if this bill is signed into law, these important student protections will be enacted by the CCC Board of Governors as part of the regulatory process implementing SB 1456.

It was my intent in authoring AB 1532 that as a part of the Governor's annual budget submission to the Legislature, the DOF will include proposed expenditures consistent with the investment plans developed in accordance with Health and Safety Code Section 39716.

Dear Mr. Wilson: My Assembly Bill 1647 seeks to curb the growth in the illegal export of waste tires overseas to be converted into bunker fuel instead of being recycled in California. AB 1647 aims to address this problem through a multifaceted approach, including streamlining and expediting enforcement actions against unlawful tire facility activities, and requiring tire brokers to register with the Department of Resources, Recycling, and Recovery, and periodically report information on tire shipment activity.

AB 1647 defines a tire broker as "a person that arranges for the shipment of used or waste tires to or from a site located within the state, or through the state . . ." While this definition is meant to include those who are actively engaged in purchasing waste tires for resale in or outside of California, it is not intended to include motor vehicle dealers, as defined in Section 285 of the Vehicle Code, or tire retailers primarily engaged in the retail sale, service, and installation of tires on customer vehicles. These businesses merely generate waste tires as a byproduct of their primary business model of selling or servicing vehicles and/or tires.

Accordingly, I wish to clarify my intent that such businesses are not required to comply with the provisions of AB 1647 applicable to tire brokers.

Dear Mr. Wilson: The basic intent of AB 2477 is to conform California law with federal law, on the bill's effective date of January 1, 2013, as to the placement of video event recorders on windshields of commercial vehicles. Federal law is currently governed by an exemption granted by the Federal Motor Carrier Safety Administration referenced on page 5, lines 25–31 of AB 2477 (as amended on June 28, 2012). The intent of the new provision, Vehicle Code section 26708(b)(14)(A), is to conform to that exemption.

The purpose of subdivisions (b)(14)(B) and (b)(14)(C) of section 26708 is to maintain conformity to federal law both in the event the current federal exemption expires and in the event the regulation is changed to incorporate the exemption. If the exemption expires, then the change in the law enacted by AB 2477 (Vehicle Code section 26708(b)(14)(A)) would become inoperative pursuant to subdivision (14)(B). However, if as is expected the federal regulation is revised to permanently adopt the exemption, the change in law enacted by AB 2477 would become operative pursuant to subdivision (14)(B) even if the federal exemption had expired. In both instances, the California Highway Patrol will make the determination of the state of the federal regulation.

This is consistent with the interpretation of the Legislative Counsel and the understanding of the California Highway Patrol.

Legislative Intent—Assembly Bill No. 685

Dear Mr. Wilson: This letter is to clarify the intent of Assembly Bill (AB) 685, which would add Section 106.3 to the Water Code to declare that it is the established policy of the state that every human being has the right to safe, clean, affordable, and accessible water adequate for human consumption, cooking, and sanitary purposes.

It is well documented that many water service providers face significant challenges in providing safe and clean water, but many also lack the capacity to overcome them without assistance, especially in rural and disadvantaged communities, where enforcement actions alone are insufficient to address the root cause of persistent problems. It is my intent with AB 685 to create a state policy priority and direct state agencies to explicitly consider it within their relevant administrative processes, measures and actions.

Therefore, subdivision (a) of Section 106.3 sets this state policy priority. It is implemented by subdivision (b), which directs relevant state agencies to consider this policy priority when engaging in agency actions that are likely to impact the safety, affordability, or adequacy of drinking water or sanitation. It is intended that subdivisions (a) and (b), together, establish a framework for administrative decision making that will improve access to safe, affordable domestic water service throughout the state.

Subdivision (b) does not direct any state agencies, including the State Water Resources Control Board, to commence proceedings to revisit existing policies and regulations to bring them into compliance with the policy priority in subdivision (a). It merely directs that when such an agency does revisit its existing policies and regulations, or adopts new policies and regulations going forward, those agencies must consider the policy priority. Therefore, it is not my intention that the State Water Resources Control Board be required by this section to alter existing policies or regulations relating to the granting, administration or enforcement of water rights.

Subdivision (c) addresses my intent that the declaration of state policy in subdivision (a) and the implementation provision in subdivision (b) do not impose a new obligation on the state to provide water service or to pay for water for those unable to afford it.

Subdivision (e) specifies that the implementation of this section shall not infringe on the rights and responsibilities of any public water system. This subdivision is intended to apply to a public water system as defined in Section 116275 of the Health and Safety Code. It is not my intent that Section 106.3 alter existing statutory requirements applicable to public water systems, including: (1) statutorily-mandated procedures to terminate water service (i) for nonpayment of water bills or (ii) for any violation of a rule or regulation adopted by a public water system or regulatory agency; (2) compliance with any applicable water quality requirement established pursuant to federal or state law; (3) compliance with any water planning process set forth in the Water Code, including but not limited to Water Code Sections 10608-10608.64, the Urban Water Planning Management Act (Water Code Sections 10610 et seq.), the Agricultural Water Planning Management Act (Water Code Sections 10800 et seq.) and Water Code Sections 10910–10915); (4) compliance with any statutory requirement pursuant to the California Environmental Quality Act (Public Resources Code Sections 21000 et seq.); (5) compliance with any statutory requirement pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (Government Code Sections 56000 et seq.); (6) declaration of a water shortage emergency pursuant to Water Code Sections 350 et seq.; and (7) compliance with any requirements pertaining to the Public Utilities Commission regulation of water utilities pursuant to the Public Utilities Code.

Finally, it is my intent that nothing in Section 106.3 prohibits or is intended to restrict future changes to existing statutes or regulations, or the adoption of new statutes or regulations appropriate and necessary to implement the policy contained in subdivision (a).

Dear Mr. Wilson: I am submitting this letter to the Assembly Journal to provide clarity as to the intent of Assembly Bill 1486 relating to hearings and disclosure of information by the Los Angeles Regional Interoperable Communications System (LA-RICS) Authority.

Assembly Bill 1486 adds Public Resources Code §21080.25, relating to environmental documentation for certain LA-RICS projects. It is my intention that LA-RICS, through its use agreements with member agencies for LA-RICS projects, include an open and noticed public meeting process by LA-RICS and the member agencies in the approval of those use agreements.

Further, it is my intent that the LA-RICS Authority will do the following for LA-RICS projects:

- Hold a noticed public meeting prior to submitting an environmental assessment, prepared pursuant to the National Environmental Policy Act, to federal agencies for approval.
- File notices of exemption for all sites it determines are exempt under AB 1486 of the 2011–2012 Regular Session.
- Include the following information on its Internet website:

 1) draft and final environmental documentation, in compliance with CEQA and NEPA; 2) the date of filing notices required pursuant to CEQA and NEPA, and 3) all notice and hearing information regarding review and approval of the environmental assessment by any federal agencies.

Finally, it is my intent that the Assembly Bill 1486 exemption does not apply to, and LA-RICS facilities will not be located on, any of the following: 1) school sites (none of the planned sites are located on school sites); and 2) cultural sites, including sacred sites as described in Public Resources Code §§5097.9 and 5097.993.

To the extent any clarification is necessary regarding the intent of this provision, I will pursue legislation to clarify these matters at the earliest opportunity.

Dear Mr. Wilson: Assembly Bill 1492 would enact provisions related to forestry resource management. Among the bill's provisions, it would impose an assessment on a person who purchases a lumber product, as defined, in this state, at the rate of 1% of the sales price. I am submitting this letter to the Assembly Daily Journal to clarify the meaning of the term "lumber product" in AB 1492.

Section 4629.5(b)(5) provides that "lumber product" means a product in which wood or wood fiber is a principal component part, including, but not limited to, a solid wood product, or an engineered wood product, that is identified in regulations adopted by the board pursuant to Section 4629.4. The paragraph further provides that "lumber product" does not include furniture, paper products, indoor flooring products such as hardwood or laminated flooring, bark or cork products, firewood, or other products not typically regarded as lumber products.

I wish to clarify that the term "lumber product," as defined in Section 4629.5(b)(5) is in no way meant to include materials used for the processing or storage of beer, wine, or spirits.
