**ASSEMBLY BILL NO. 16—Patterson.** An act to add Section 155.7 to the Streets and Highways Code, relating to state highways.

**ASSEMBLY BILL NO. 17—Achadjian (Coauthor: Linder).** An act to amend Section 39719 of the Health and Safety Code, relating to greenhouse gases, and making an appropriation therefor.

**ASSEMBLY BILL NO. 18—Linder (Coauthors: Achadjian and Obernolte).** An act to add Section 9400.5 to the Vehicle Code, relating to transportation.

**ASSEMBLY BILL NO. 19—Linder.** An act to amend Sections 13975 and 14500 of, and to repeal Section 14534.1 of, the Government Code, relating to transportation.

**ASSEMBLY BILL NO. 20—Beth Gaines.** An act relating to state government, and making an appropriation therefor.

**ASSEMBLY BILL NO. 21—Obernolte (Coauthors: Travis Allen, Bigelow, Chávez, Grove, Lackey, Linder, Mayes, Patterson, and Steinorth).** An act to add Section 21168.15 to the Public Resources Code, relating to environmental quality.
