RE: Letter to the Journal

Dear Mr. Wilson: I have authored Assembly Bill 473, which would require owners of multifamily dwellings to arrange for recycling services consistent with state or local law requirements. For purposes of this bill, "multifamily dwelling" is defined as a building of five or more living units.

While it is my desire and goal to have all single and multifamily dwellings in California provide recycling services, I would like to make clear that AB 473 does not apply to forms of real property where an individual owner owns an interest in common in a portion of that real property, coupled with a separate interest of fewer than five units, and which are governed by an association.

Each individual unit owner who owns his or her separate interest of fewer than five units, together with interest in the common area, is not subject to the provisions of AB 473. An association that is not the owner of five or more units is not subject to the provisions in this bill. However, nothing in AB 473 or in this letter is meant to discourage an owner or an association from voluntarily providing recycling services.

REQUEST FOR UNANIMOUS CONSENT TO PRINT IN JOURNAL

Dear Mr. Wilson: I am submitting this letter to clarify the intent of my Assembly Bill 1093.

AB 1093 provides that for purposes of determining whether to grant or deny a workers' compensation claim, if an employee is injured or killed by a 3rd party in the course of the employee's employment, no personal relationship or personal connection shall be deemed to exist between the employee and the 3rd party based only on a determination that the 3rd party injured or killed the employee solely because of the 3rd party's personal beliefs relating to his or her perception of the employee's race, religious creed, color, national origin, age, gender, disability, sex, or sexual orientation.

It is my intent that this legislation precludes denial for injury or death to an injured worker when the occurrence is motivated solely by the third party's discriminatory beliefs or perception based on race, religious creed, color, national origin, age, gender, disability, sex, or sexual orientation. It is also my intent that this bill does not abrogate defenses of any party that would apply in cases where there is a prior relationship, but to clarify that an occurrence motivated by discriminatory beliefs or perceptions based on race, religious creed, color, national origin, age, gender, disability, sex, or sexual orientation, without more, does not constitute a relationship.

Dear Mr. Wilson: The purpose of this letter is to clarify my intent as author of AB 313 on issues contained within the bill.

An unknown number of common interest developments may have been using the method of determining assessments (as set forth in AB 313) since before 1978, when Cal. Const., Article 13A (commonly known as Proposition 13) was adopted. When county tax assessors began valuing properties under the Proposition 13 methodology, such common interest developments may have used the tax assessors' new valuations in setting their own assessments on the separate interests within the common interest development. One purpose of this legislation is to confirm the continuing validity of such practice by common interest developments. Therefore, for those common interest developments that initiated such practice before December 31, 2009, this legislation is declaratory of existing law with respect to the validity of levying of assessments based on the county tax assessor's valuation of such separate interests.
