**MESSAGES FROM THE GOVERNOR**

Governor's Office, Sacramento  
August 31, 1999

*To the Members of the Assembly:*

I am allowing Assembly Bill No. 1323 to become law without my signature.

As a result of the voter approved Proposition 140, legislative budgets were reduced. Fewer than two dozen legislative employees accepted an early retirement option anticipating their retirement benefits would be calculated on the highest twelve month basis.

The bill that would have allowed that early retirement option for these few employees was never enacted.

While I do not like to single out a group of employees, this appears to be a unique situation.

**Veto Message—Assembly Bill No. 461**

Governor's Office, Sacramento  
September 1, 1999

*To Members of the Assembly:*

I am returning Assembly Bill No. 461 without my signature.

This bill would reinstate a previously repealed requirement that Health Services (DHS) annually report to the Legislature findings from its review of Medi-Cal rates of payment to physicians and dentists. This bill is not necessary since the DHS annually surveys reimbursement rates and this information is readily available to the Legislature when requested. In addition, the additional work required by this bill could not be performed by existing departmental staff, yet no provision has been made for additional administrative resources.
