#### Legislative Intent—Assembly Bill No. 1022

August 28, 2003

The Honorable Herb J. Wesson, Jr. Speaker, State Assembly State Capitol Sacramento, California

Dear Mr. Speaker: AB 1022, as amended on July 17, 2003, is red light camera reform legislation intended to advance many of the recommendations found in a report by the independent California State Auditor regarding suggested improvements to red light camera programs.

The provisions of AB 1022 are intended to apply prospectively and retroactively. However, as many local governments are currently obligated under existing contracts with red light camera vendors, the bill recognizes that it would be neither fiscally nor legally sound to require local governments to default on their existing contracts in order to comport with the provisions required by AB 1022. Accordingly, the provisions of AB 1022 take effect on January 1, 2004, except where there is an existing contract between a local governmental entity and a red light camera vendor, in which case the provisions of the bill will take effect for those existing contracts upon such time as those existing contracts are amended, renewed, extended, or terminated.

As AB 1022 is being contemplated by the Legislature, some local governments are facing legal challenges over aspects of their existing contracts with red light camera vendors. With respect to litigation arising from existing law, AB 1022 is not intended to suggest or imply the legality or illegality with respect to any existing law, nor is it intended to imply that any contract based upon existing law is valid or invalid.

I respectfully request that this letter be printed in the Assembly Journal.
