Pérez and Conway: Recently, the Department of Human Resources (CalHR) reached a new Tentative Agreement/MOU with PECG, representing Bargaining Unit 9 — Professional Engineers. Upon approval of the Legislature and the Governor, and ratification by the membership, these agreements will be effective July 2, 2013, through July 1, 2015.

This agreement will roll over language from past agreements and make changes primarily in the area of employee compensation.
