Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the Department of Corrections' (department) Parole Outpatient Clinic Program (program). This report concludes that the program has failed to serve many of the parolees that the department has determined could most benefit from clinic services. These are primarily mentally ill parolees, but also include other parolees who may pose a threat to public safety, such as sexual offenders. Even though recent changes have resulted in some improvement, the program still failed to serve almost 40 percent of mentally ill inmates who were paroled between October 2000 and March 2001. The program expects additional improvement in its ability to serve mentally ill parolees when it implements a new data management system shortly. However, because the data management system was not yet in use when we concluded our work, we could not assess its effectiveness. Recent changes, both inside and outside the program, will likely increase the demand for program services and highlight the program's need to increase its effectiveness.
