Legislative Intent—Assembly Bill No. 548

Dear Mr. Wilson: I have authored Assembly Bill 548, which would require owners of multifamily dwellings to arrange for recycling services consistent with state or local law requirements. For the purpose of this bill, an owner of a multifamily dwelling, defined as a residential facility that consists of five or more living units, shall be responsible for arranging appropriate recycling services.

While it is my desire and goal to have all single and multifamily dwellings in California provide recycling services, I would like to make clear that AB 548 does not apply to forms of real property where an individual owner owns an interest in common in a portion of that real property, coupled with a separate interest of fewer than five units, and which are governed by an association.

Each individual unit owner who owns his or her separate interest of fewer than five units, together with interest in the common area, is not subject to the provisions of AB 548. An association that is not the owner of five or more units is not subject to the provisions of AB 548. However, nothing in AB 548 or in this letter is meant to discourage an owner or an association from voluntarily providing recycling services.

Furthermore, due to potential variation in locally available programs and conditions at each multifamily site, the bill is specifically intended to increase recycling opportunities for the residents of multifamily dwellings without being overly prescriptive regarding the particular type of recycling collection services required.

It is my intent that the expertise of the waste handling and recycling service providers operating in each community be given great weight by all parties in determining what recycling services are appropriate for the residents of a multifamily dwelling.

The bill is not intended to displace the current waste handling service provider.

I am signing Assembly Bill 905, which would authorize the Superintendent of Public Instruction (SPI) to extend the currently authorized 60-working-day period of eligibility for child care when the parents of a family are seeking employment, by an additional 60-working days.

I am sympathetic to the need of these parents to maintain state subsidized child care, especially in areas with disproportionately high numbers of seasonal employment. However, I am also cognizant of the cost pressures associated with allowing the SPI to have this discretion, and the displacement of other families currently on the waiting list for child care. Therefore, I am encouraging the SPI to act judiciously in granting these extensions, taking into account any pressure on the State's current operating deficit and the impact on families who are expecting to get off the existing waiting list.

With that understanding, I am signing this bill.
