#### **MESSAGES FROM THE GOVERNOR**

*To the Members of the California Legislature:* 

I am signing Assembly Bill 109 which would make it specifically unlawful for public school employers to knowingly provide inaccurate information regarding its financial resources with respect to information requested by an exclusive representative during the collective bargaining process and thereafter.

While existing law already generally provides that a public school employer must negotiate "in good faith" with the exclusive representative of employees, it does not specifically define the "knowing provision of inaccurate financial information" as a "per se" failure to bargain in good faith. By signing this bill, I am clarifying in the law that such actions constitute bad faith bargaining under EERA.

A successful collective bargaining process depends upon both parties operating in good faith.

To the Members of the California Legislature:

I am signing Assembly Bill No. 1207, which would allow school districts, community college districts, and county offices of education the discretion to provide a choice of two early retirement incentive plans for members of the California State Teachers' Retirement System. One plan would extend two additional years of service credit if certificated employees retire during a designated time period. The other plan would provide two additional years of service credit and two years of additional age credit for retirements that occur during a designated time period.

In the future, I am prepared to only sign a bill that similarly provides the Director of the Department of Personnel Administration with the discretion whether or not to offer a retirement incentive to State employees, and to utilize the collective bargaining process to ensure that the incentive, if offered, is appropriately tailored to achieve cost savings for the State.
