Dear Mr. Wilson: This letter clarifies a provision of my Assembly Bill 843 as voted upon for concurrence today.

Subdivision (j) of Section 480 contained in Section 1 of the bill provides that if there is no address specified for mailing tax information on either the recorded instrument or document evidencing a transfer of an interest in real property or manufactured home or the filed preliminary change in ownership report, or the transferee has not provided a subsequent address for mailing tax information, then the assessor shall mail the request to the transferee at the transferee's current address.

It is my intent that in the situation when the request must be mailed to the transferee at the transferee's current address that if the assessor mails the request to the transferee at the transferee's last known address then the assessor would be in compliance with the terms of that provision. However, in no event shall this letter be construed to impair the transferee's argument for penalty abatement because the transferee did not receive the written request.
