AB 824 creates a process for students to petition county offices of education and charter public schools to add an advisory student board member to their school boards. As the author of this measure, I respectfully submit this letter to be printed in the Assembly Journal in order to provide clarification on the intent of AB 824 as it relates to a material revision of a school's charter.

In accordance with Education Code Section 47607, charter schools may be required to seek authorizer approval of a "material revision" of their charter. It is not my intent in authoring AB 824 that a charter school's compliance with these provisions should constitute a material revision to a school's charter under the meaning of Section 47607.
