MESSAGES FROM THE GOVERNOR

The following veto message from the Governor was received and ordered printed in the Journal and the bill ordered to the unfinished business file:

Veto Message—Assembly Bill No. 627

Governor's Office, Sacramento September 6, 2003

To the Members of the California Assembly:

I am returning Assembly Bill 627 without my signature.

This bill would require the Resources Agency, until January 1, 2008 to prepare an annual report containing specified information summarizing expenditures on the California Clean Water, Clean Air, Safe Neighborhood Parks, and Coastal Protection Act of 2002.

Currently, the Resources Agency is required by Chapter 8, Statutes of 2002 to prepare an annual summary of expenditures related to Proposition 40 programs. The Resources Agency has contracted with the Department of Finance Office of Audits and Evaluations to annually audit Proposition 40 expenditures. This audit report will address the mandates of Chapter 8 and will be available on the Internet.

In addition, the Legislature has tasked the Resources Agency to create a public website that will centrally list all projects receiving bond funds. The website will include, information on the section of the bond act for each appropriation and award, the name of the department administering the appropriation, the names of projects and the names of the entities administering the projects, project dollars awarded and a general description of the project and its location. This website will cost \$1.4 million to create and maintain for six years. A search tool will also be available so that individuals accessing the website will be able to query the database, sort grant projects by area, and view a map indicating the location of each project. The website will also include summary information on bond allocations, amounts appropriated, lead agencies to whom funding has been made available, and fund balances remaining for appropriation.

This measure would require the following additional specific information to be contained in the annual report:

- A list of expenditures for major projects, including administrative costs
- A description of major projects that have been approved
- The amount and location of habitat acquired by bond funds and species targeted for protection, listed by county only.

While this bill reflects the recommendations of the Legislative Analyst's Office, I am concerned that these additional requirements will increase costs without providing necessary additional information.

First, regarding administrative costs, the Resources Agency oversees departments' implementation of dozens of individual grant programs. Expenditures related to each program are very complex. Reporting on administrative costs for individual projects would be very burdensome and costly, and would likely be too complex to be of significant analytical value. Departments typically track and account for administration costs by program and not by project. Thus, the current tracking and accounting systems in place in the 17 departments administering Proposition 40 funds would not capture this information. Additionally, annual project expenditures are not necessarily meaningful indicators of program activities, which is why the website will be reporting all awards of funding.

From a fiscal standpoint, these additional requirements would add substantial new costs in the departments to develop and implement new tracking systems, thereby diverting funds from funding projects. As the website will provide information on all projects awarded funds and the user will have the ability to query the database, there is no benefit to imposing additional annual reporting requirements on the Secretary of the Resources Agency.

I commend the author and the Legislature for their interest in and support of enhanced public information on Proposition 40. I will be monitoring the progress of the Resources Agency as they continue to implement existing reporting requirements to ensure that the public has information that is meaningful and easily accessible.

Legislative Intent—Assembly Bill No. 1216

September 5, 2003

Mr. Dotson Wilson Chief Clerk California State Assembly State Capitol, Room 3196 Sacramento, California

Dear Mr. Wilson: AB 1216, as amended on July 1, 2003, will have a positive economic impact by reducing fire suppression costs to state and local government and will limit damages to lives and property, thereby reducing post-fire recovery costs and insurance claims. Building standards proposed under the authority of this statute will combine prescriptive and performance-based approaches to evaluate the fire safety of building components, thereby promoting innovation and competition in material manufacturing and building design. In an effort to maintain housing affordability, I believe the State Fire Marshal will propose to use materials with the least cost when different approaches yield the same fire safety benefits. It is my understanding that many of the building standards will focus on details of construction, which should have a minimal fiscal impact. It is my intent that building standards applicable in "urban wildland interface communities," as defined, will be implemented without any action by local jurisdictions that is not already mandated pursuant to other statutes, unless that jurisdiction decides to modify the areas of applicability in the manner established by this legislation. Fire safe construction, provided by in part AB 1216, is the next logical step in protecting communities' urban-wildland interface from wildfire.
