Dear Ms. Parker: This is to advise you that as of September 5, 2025, at 11 a.m. the unofficial results of the Special General Election held on Tuesday, August 26, 2025, for State Assembly District Sixty-Three show that Natasha Johnson received 34,853 votes or 53.5% of the total number of votes cast for that office.

As of September 5, 2025, at 11 a.m., Riverside County has 491 ballots left to cure.

According to the unofficial results, it appears that Natasha Johnson has received the majority of votes cast for the State Assemblymember Sixty-Third District.

To the best of the Secretary of State's knowledge and belief at this time, there is no contest to this election.

As soon as the official results are certified to this office by Riverside County's registrar of voters, an official Certificate of Election will be prepared for transmittal as required by law.

Assembly Member Aguiar-Curry was granted unanimous consent that the following statement of legislative intent relative to Assembly Bill No. 1504 be printed in the Journal:

**Legislative Intent—Assembly Bill No.1504**

Dear Ms. Parker: I am submitting this letter to be printed in the Assembly Journal for the purpose of clarifying the intent of a provision in AB 1504. The Assembly Committee on Business and Professions annually participates in a bicameral oversight process wherein the authorizing statutes for entities responsible for licensing, certifying, or registering individuals engaged in regulated professions are subject to repeal unless extended by the Legislature in a vehicle that traditionally contains reforms to address issues identified in committee reports and hearings. AB 1504 is this year's sunset bill for the California Massage Therapy Council (CAMTC).

While the majority of entities that undergo sunset review are boards and bureaus within the Department of Consumer Affairs (DCA), CAMTC is a private nonprofit organization. Following multiple unsuccessful legislative efforts to establish a state licensing board, SB 731 (Oropeza) was enacted in 2008 to provide for voluntary certification of massage therapists by a nongovernmental body. The legislative record for SB 731 demonstrates that the Legislature's intent was that SB 731 would "create" this organization, although private individuals ultimately incorporated the nonprofit and sought tax-exempt status for the organization in accordance with the bill.

As a private nonprofit, CAMTC is not subject to the limitations and requirements typically imposed on state entities, including civil service laws, and the substantial compensation paid to CAMTC's chief executive officer (CEO) has historically been scrutinized by the Legislature. This issue was first raised in 2014, when the CEO of CAMTC earned a \$260,000 annual salary, and the issue was raised again in 2019, at which point that salary had been increased to \$369,000. During the sunset review of CAMTC earlier this year, it was revealed that the CEO's annual salary had risen to approximately \$616,000.

In response to the Legislature's prior criticisms, CAMTC commissioned a study in 2019 to compare the salary paid to CAMTC's CEO to other nonprofit executives and determined that the compensation was within an appropriate range. However, the nonprofits identified as comparable "peer groups" were primarily professional and trade associations such as the California Chamber of Commerce and the

California Medical Association, which resulted in CAMTC self-imposing a salary ceiling of approximately \$705,000 per year. By comparison, a study commissioned by the DCA the same year found that the median annual salary for the executive officer of a state licensing board was approximately \$107,000.

Following further discussion during this year's sunset review process, the following language was included in CAMTC's sunset bill, AB 1504: *Notwithstanding any other law, the total annual salary for any individual employed or contracted by the council shall not exceed the annual salary provided pursuant to Section 11550 of the Government Code during that fiscal year.*

This provision would prohibit CAMTC from paying its CEO and other staff an annual salary that is greater than the salary established in statute for specified executives in state government, including the Secretary of the Business, Consumer Services, and Housing Agency, who oversees the DCA and approximately a dozen other entities. As of the most recently approved increase approved by the Department of Human Resources, this would represent a cap of approximately \$247,000.

It is important to acknowledge that private nonprofits like CAMTC are typically only required to ensure that compensation is "reasonable" to retain tax-exempt status from the Internal Revenue Service. While some donors may take executive compensation into consideration when choosing which organizations to financially support, it is normally not the role of the Legislature to dictate the level of pay that is appropriate for a private nonprofit to attract and retain key personnel while fulfilling its charitable purpose. CAMTC, however, is primarily funded through mandatory fees charged to massage therapists seeking certification, which is required in a majority of the state to practice. Unlike individuals making voluntary donations, certified massage therapists have no choice but to contribute to the funding of CAMTC, which recently raised its fees by 50 percent while it has continued to approve raises for its CEO.

The salary cap established in AB 1504 narrowly addresses the unusual nature of CAMTC, which is entrusted with serving an important function ordinarily administered by a state entity. This language is unique to this circumstance, and is in no way an indication of the Legislature's intention to establish compensation caps on any other nonprofits in the future. I believe it would be inappropriate for the legislature to establish such caps on nonprofits.

Thank you for the opportunity to clarify the intent of AB 1504.
