Dear Mr. Wilson: As author of Assembly Bill (AB) 34, I wish to clarify the meaning intended by the phrase "provision for services to be client-directed." This phrase was added in the September 3 amendments to AB 34.

As used in my bill, the term "client-directed" is intended to provide for services to be focused upon and directed toward the needs of the individual clients, and generally means the following:

• Service planning and delivery for each individual client that is directed at the whole client, including support for the

client in areas such as housing, employment, education, social interaction, health, parenting, and other aspects of the client's life activities:
