#### MESSAGES FROM THE GOVERNOR

The following message from the Governor was received and ordered printed in the Journal:

Governor's Office, Sacramento September 8, 2003

To the Members of the California Legislature:

I am pleased to sign Assembly Bill 310, which requires a school employer (K–12) or community college district) to transmit dues and fair share fees to the employee organization within 15 days and prohibits the State Board of Education from approving waivers for this requirement.

A school employer should expeditiously transmit membership dues and agency fees to an exclusive representative. It is my understanding that all school districts currently transmit dues and fair share fees to the employee organization within 15 days and that Los Angeles Unified has voluntarily agreed to do this within 15 working days. This bill simply designates the time period in which dues and agency fees must be transmitted. This action does not meet a higher level of service or create a new program, as current law states that all employee organizations have the right to have membership dues deducted and current law further requires school districts to transmit the dues on the same designated date of each month.
