Legislative Intent—Assembly Bill No. 900

RE: AB 900 (Buchanan and Gordon)

Dear Mr. Wilson: Assembly Bill 900 would enact the Jobs and Economic Improvement Through Environmental Leadership Act of 2011. We are submitting this letter to the Assembly Daily Journal to clarify the meaning of three provisions in AB 900.

Section 2180(a)(1) provides that "[a] residential, retail, commercial, sports, cultural, entertainment, or recreational use project that is certified as LEED silver . . ." qualifies for the special judicial review process provided in the bill. AB 900 requires project developers to apply for this special process before the project is approved by the lead agency. But buildings cannot be certified as meeting LEED standards until after they are built. To rectify this inherent contradiction, we wish to clarify that a project must be "designed" to the LEED silver standard rather than "certified" as LEED silver.

Section 21180 (a) defines an "applicant" for the special judicial review process to be "a public or private entity or its affiliates, or a person or entity that undertakes a public works project" One of the non-binding legislative findings, Section 21178(e), states that "These projects are privately financed or financed from revenues generated from the projects themselves and do not require taxpayer financing." We wish to clarify that "[These projects" in subdivision (e) refers specifically to the projects described in the previous subdivision (d): "large construction projects . . . in various regions of the state" Subdivision (e) is in no way intended to conflict with the definition of "applicant" in Section 21180(a) or to suggest that the bill applies only to projects that are sponsored or financed by private entities.

Section 21185(a)(5) states that "the court may grant extensions of time only for good cause shown and in order to promote the interests of justice." As noted in the bill analyses by the Senate Environmental Quality Committee and the Assembly Floor Analysis, it is our intention that this language applies to both requests by parties to the litigation for an extension of time and to orders made by the court to extend time, on its own motion, upon finding that the necessary criteria are met.

Dear Mr. Wilson: The purpose of this letter is to clarify AB 1329, which amends Section 103885 of the Health and Safety Code.

The California Cancer Registry (CCR) has operated effectively for over 25 years through a public/private partnership between a network of regional cancer registries operated by independent research institutes, academic institutions and the State of California.

CCR has become a world-renowned program of cancer registration, surveillance and research that, in its present form and composition, has leveraged the expertise and strengths of its partners, including the California Department of Public Health (CDPH), nonprofit research institutes, universities, hospitals, and others, to benefit from substantial federal funding awarded to the regional cancer registries in California by the National Cancer Institute's Surveillance, Epidemiology, and End Results Program (SEER) and the US Centers for Disease Control and Prevention's National Program of Cancer Registries (NPCR).

It is the intent of AB 1329 to provide CDPH with the additional authority and flexibility to maintain and advance the excellence established in the CCR through a competitive process to issue a single contract, grant, or allocation to an agency. It is not the intention of the bill to remove any existing authority in current law that may allow CDPH to enter contracts, fund and support the CCR.

Dear Mr. Wilson: My office has been working closely and collaboratively with the League of California Cities and others to draft AB 1344 in response to the many governance challenges that have occurred in the City of Bell. My office drafted recent amendments intended to ensure that local government compensation discussions are carried out in public view with sufficient opportunities for public input. One of the allegations raised by good government advocates and law enforcement leaders is that public officials in the City of Bell enriched themselves by making compensation decisions without an open and accessible public process. My bill would put an end to that practice by setting a higher standard of transparency for local government compensation decisions.

The League of California Cities has suggested that the restrictions in AB 1344 may prevent local agencies from discussing budget and related financial issues as may be required for urgent or emergency needs. That is not the intent of the bill. Local agencies must be authorized to discuss fiscal issues as they arise. I am committed to continuing to work with the League of Cities and others to ensure public confidence in California's public agencies while preserving the authority of those agencies to operate efficiently and effectively.

Dotson Wilson: In authoring AB 720, it is not my intent to restrict county force account work necessary to facilitate capital projects for the purposes of contracting to the private sector. This would typically include design, engineering, inspection, testing, and other force account work necessary to administer private contracts.

In my opinion, changes should be made to the State Controller's Guidelines Schedule 199 "Instructions for Preparing the Annual Road Report" to ensure that there is a distinction between force account reported for facilitating private contracts versus force account reported for actual construction for new road construction and reconstruction projects, prior to the effective date of AB 720.

Revisions to the reporting guidelines may also be necessary to identify work performed by road commissioner authority under subdivision (c) of Section 20395 pursuant to Section 22031 (b) (2) of AB 720. I encourage the State Controller and his staff to work with all stakeholders to update the State Controller's Guidelines Schedule 199 "Instructions for Preparing the Annual Road Report."

RE: Letter to the Journal—Assembly Bill 56

Mr. Wilson: As the author to Assembly Bill 56, I am writing to clarify that it is the intent of the Legislature that whenever the terms "pipelines", "intrastate transmission line," or "intrastate distribution line" is used in Assembly Bill 56, those terms shall be defined as follows:

"Commission-regulated gas pipeline facility" means an intrastate gas pipeline facility as defined in Section 60101 of Title 49 of the United States Code, that is subject to the safety regulatory authority of the commission to the extent authorized in the certification submitted by the commission and approved by the United States Secretary of Transportation pursuant to Section 60105 of Title 49 of the United States Code, including each of the following pipelines:

- (1) An intrastate distribution line, which is a pipeline that is not subject to the jurisdiction of the Federal Energy Regulatory Commission pursuant to Section 717(b) of Title 15 of the United States Code because it is used for the local distribution of natural gas.
- (2) An intrastate transmission line, which is a transmission pipeline that the commission, pursuant to Section 717(c) of Title 15 of the United States Code, has certified to the Federal Energy Regulatory Commission as being subject to the regulatory jurisdiction of the commission over rates and service. For these purposes, a transmission pipeline means a pipeline other than a gathering line that: (A) transports gas from a gathering line or storage facility to a distribution center, storage facility, or large volume customer that is not downstream from a distribution center, (B) operates at a hoop stress of 20 percent or more of specified minimum yield strength, or (C) transports gas within a storage field.

This language is consistent with the definition of a "commission-regulated gas pipeline facility" as contained in Section 950(a) of the Public Utilities Code found in Senate Bill 44 which was enrolled in the 2011 session of the California State Legislature.

Dear Mr. Wilson: The purpose of this letter is to clarify my intent with Assembly Bill 42 (Huffman), which authorizes the Department of Parks & Recreation (DPR) to enter into operating agreements with nonprofit organizations to operate State Park units. Based on the May 13, 2011 list released by DPR, 70 parks across the state are facing permanent closures. AB 42 provides an opportunity to help keep some of those 70 parks open, by utilizing the efforts and resources of qualified nonprofit organizations to operate park units, provided the agreements to do so will assist the department in keeping open a State Park that would otherwise be subject to closure. The skills, expertise, commitment and community connections that qualified nonprofit organizations have can and may be a critical factor in keeping State Parks open.

The intent of this bill is to minimize the number of state parks that are subject to closure as a result of recent state budget reductions that cut \$11 million from DPR's budget. It is not the intent of this bill to alter or affect the application of existing law with regard to the state's authority to contract out, or with regard to the civil service rights and processes that state park employees are currently entitled to, based on their bargaining unit contracts. AB 42 does not in any way affect those rights and processes already in place.

These are challenging times for our State Park System, and I believe AB 42 is an important tool to ensure continued protection of our State Parks.

Dear Mr. Wilson: The purpose of this letter is to clarify the legislative intent in Assembly Bill 964 (Huffman) of technical amendments to Water Code Section 1525(d)(3). AB 964 was introduced to define "small irrigation uses" and adds those uses to the existing statutes found in Article 2.7, Part 2, Division 2 of the Water Code, which allow persons with small domestic uses and livestock stockponds to apply for a right to appropriate water by registering with the State Water Resources Control Board and applying the water to reasonable and beneficial use with due diligence.

This bill makes conforming changes to Section 1525 of the Water Code so that small irrigation uses are subject to the same State Water Resources Control Board fees as small domestic uses and livestock stockponds. In addition, this bill includes technical amendments to Section 1525, subdivision (d)(3) concerning the relationship between the fee schedule established by the State Water Resources Control Board and appropriations by the Legislature for water rights program activities. The existing language of Section 1525(d)(3) states that fees shall be set to conform with the revenue levels in the annual Budget Act.

However, in 2009, the Legislature passed SB 8 (Steinberg) from the 2009–10 Seventh Extraordinary Session, which continuously appropriates three million seven hundred fifty thousand dollars (\$3,750,000) to the State Water Resources Control Board, without regard to fiscal years, on an annual basis, from the fee revenue in the Water Rights Fund for the purposes of funding 25.0 permanent water right enforcement positions.

Since this continuous appropriation is separate from, and in addition to, the revenue levels set forth in the annual Budget Act, the technical amendment specifies that fees will conform with amounts appropriated, which include both the revenues set forth in the Budget Act and the continuous appropriation in SB 8 X7. These amendments are declaratory of existing law and consistent with State Water Resources Control Board practice. They do not expand the State Water Resources Control Board's fee setting authority.

Dear Mr. Wilson: The purpose of this letter is to confirm the intended scope of the financial and compliance audit provisions contained in Sections 1 and 3 of Assembly Bill 165, related to the imposition of pupil fees for participation in educational activities, for the 2011–12 fiscal year.

AB 165 states that these audit provisions shall be added to the audit guide adopted pursuant to Education Code Section 14502.1 commencing with the audits of the 2011–12 fiscal year. These audit provisions are intended to ensure local educational agencies protect pupils' constitutional rights by fulfilling their responsibilities under proposed Education Code Section 49012 and Education Code Section 35186 (as amended by AB 165). Consequently, because local educational agencies would not be required to take any actions pursuant to these code sections (as added and amended by AB 165) prior to the effective date of the bill, January 1, 2012, the audits of the 2011–12 fiscal year are intended to verify compliance with the bill's provisions on or after January 1, 2012.

Legislative Intent—Assembly Bill No. 1102

Dear Mr. Wilson: The purpose of this letter is to clarify the intent of Section 8545.2(b) and (d) of Assembly Bill 1102 of the 2011–2012 Regular Session. It is the intent of the Legislature that Section 8545.2, as written, is declaratory of existing law. This section, as written, clarifies the existing authority of the State Auditor to obtain confidential records, including, but not limited to, records that are confidential based on a statutory or common law privilege or some other provision of law, during the course of an audit or investigation. Further, this section, as written, clarifies that providing those records to the State Auditor does not result in a waiver of privilege.

Specifically, Section 8545.2 (b) and (d) state:

(b) For the purposes of access to and examination and reproduction of the records and property described in subdivision (a), an authorized representative of the State Auditor is an employee or officer of the state or local governmental agency or publicly created entity involved and is subject to any limitations on release of the information as may apply to an employee or officer of the state or local governmental agency or

publicly created entity. For the purpose of conducting any audit or investigation, the State Auditor or his or her authorized representative shall have access to the records and property of any public or private entity or person subject to review or regulation by the public agency or public entity being audited or investigated to the same extent that employees or officers of that agency or public entity have access. No provision of law providing for the confidentiality of any records or property shall prevent disclosure pursuant to subdivision (a), unless the provision specifically refers to and precludes access and examination and reproduction pursuant to subdivision (a). Providing confidential information to the State Auditor pursuant to this section, including, but not limited to, confidential information that is subject to a privilege, shall not constitute a waiver of that privilege. This subdivision does not apply to records compiled pursuant to Part 1 (commencing with Section 8900) or Part 2 (commencing with Section 10200) of Division 2.

(d) For purposes of this section "confidentiality of records or property" means that the record or property may lawfully be kept confidential as a result of a statutory or common law privilege or any other provision of law.

Section 8545.2 of Assembly Bill No. 1102, as written, makes non-substantive, technical changes that clarify existing law relating to the Bureau of State Audit's (Bureau) authority to access confidential records. During the course of an audit or investigation, the bureau routinely obtains confidential records, including confidential records that may be privileged, such as those protected by the attorney-client, attorney work product, and deliberative process privileges.

Since the date of its enactment, Section 8545.2 has given the bureau the same right of access to a public entity's records as possessed by the officers and employees of the public entity; thus, the bureau is authorized to obtain any privileged documents that the entity has within its possession or which it has a right to obtain. Related to that, Section 8545.2 has always required the bureau to maintain the confidentiality of information provided during an audit or investigation, including privileged information, by complying with the same legal obligations regarding confidentiality that apply to the entity that provided the information. Accordingly, releasing confidential and privileged information to the bureau does not alter its confidentiality or waive any asserted privilege.

Currently, the bureau is conducting an audit of the child welfare systems of four counties, including Los Angeles County. Despite the unambiguous and plain language of existing Section 8545.2, the Los Angeles County Board of Supervisors (county) refuses to release to the State Auditor the "death reviews" it performs when a child dies within the system, claiming these reviews are protected by the attorney-client/work product and official information privileges, and that releasing the death reviews to the bureau will constitute a waiver of privilege. Unlike other auditees—including the Administrative Office of the Courts, the State Bar, the Attorney General, and the highest levels of the Administration—who, upon reviewing existing Section 8545.2, recognize that the Legislature designed the law to provide the bureau

complete access to all confidential information, including information that is privileged, without any waiver of the privilege, the county insists on litigating the matter, imposing unnecessary cost on to taxpayers and delaying the State Auditor's important work.

To avoid costly, unnecessary litigation and to expedite the bureau's access to information that may improve the protection of children within the county's child welfare system, Section 8645.2 as written will clarify the Legislature's original intent that the bureau has access to all information held by entities subject to audit, including confidential information for which an entity may assert a privilege, and that release of such information does not constitute a waiver of any asserted privilege. As written, this section is declaratory of existing law.

Dear Mr. Wilson: We respectfully submit this Letter to the Journal to document the legislative intent of AB 155, passed by this body in 2011.

As the authors and co-author of AB 155, we are writing to clarify our intent with regard to Revenue and Taxation Code Section 6203(c)(5)(A)–(C). These provisions were meant to draw a clear line between activities that are "mere advertising" versus more sufficiently meaningful in-state activity that should properly be characterized as "soliciting business" for purposes of meeting the definition of a "retailer engaged in business in this state." Given the evolving nature of online advertising, and the anonymous manner in which it may be delivered to online customers, it is important to note that, in isolation, online advertising, including those ads tied to Internet search engines, banner ads, click-through ads, Cost Per Action ads, links to retailer websites and similar online advertising services should not be considered a "referral" under subparagraph 5(A), nor "direct or indirect solicitation specifically targeted at potential customers in this state" under subparagraph 5(C). Those types of advertising services are generated as a result of generic algorithmic functions and are anonymous and passive in nature and thus do not rise to the level of referring or soliciting business. Agreements for such advertising services are not covered, unless the person entering the agreement also engages in other activities on behalf of the retailer in this state—such as sending flyers or making phone calls—that are specifically targeted at customers in this state.

RE: Letter of Intent for Journal—AB 23 (Ch. 91, Statutes of 2011) Dear Chief Clerk Wilson: I introduced AB 23 in the aftermath of the Bell scandal that came to light last August. While Bell's fraudulent activities were many, I focused AB 23 on correcting the deceptive scheme city leaders employed to pad their salaries by creating sham paid boards/commissions and then convening them all in one day to collect multiple stipends.

In order to prevent future abuse, AB 23 requires the clerk or a member of the governing body to announce, when holding simultaneous or sequential meetings, the amount each public official will receive for attending. AB 23 provides an exception from the bill's provisions "if the amount of compensation is prescribed in statute and no additional compensation has been authorized by a local agency."

To clarify this language, it is my intent that the exception in AB 23 does apply to local agencies if compensation is within the statutory limits. For instance, compensation for directors of county sanitation districts is subject to limitations prescribed in both the Health and Safety Code, which stipulates that stipends can be up to \$100 per meeting, and the Water Code, which allows this amount to be raised by up to 5% per year. AB 23 would apply only if compensation at the local level went beyond these statutory limits.

Dear Chief Clerk Wilson: I introduced Assembly Bill 358 to enhance the efficiency and solvency of the Underground Storage Tank Cleanup Fund. This Fund provides a means for petroleum underground storage tank (UST) owners and operators to meet the federal and state requirements when a tank leaks. The purpose of this letter is to clarify my intent for AB 358 in the following two instances.

First, the Health and Safety Code allows shared jurisdiction of UST cleanup cases between the State Water Board, a Regional Water Board, and local agencies. From time to time, an agency that is acting as the lead agency may transfer the regulatory lead to another agency. There are no restrictions on the timing of these transfers or the reason for the transfer, including whether or not the site has been petitioned for closure. AB 358 does not change this flexibility. I encourage agencies to coordinate these transfers so that there is as little inconvenience to the regulated public as possible.

Second, AB 358 amends Section 25296.10 of the Health and Safety Code by adding:

(i) On or after January 1, 2012, uniform closure letters issued pursuant to subdivision (g) shall include language notifying the owner, operator, or other responsible party of the 365-day claim filing deadline specified in paragraph (1) of subdivision (l) of Section 25299.57.

To clarify, it is my intent that this paragraph becomes active on January 1, 2012 and continues to remain applicable thereafter.

Dear Chief Clerk Wilson: I introduced AB 1117 in order to establish a prohibition of contact with animals post-conviction of specified misdemeanor and felony animal abuse crimes.

AB 1117 includes language allowing those convicted of animal abuse who are also owners of "livestock" to petition for exemption from the ownership prohibition. In order to be exempted, livestock owners must demonstrate that the prohibition would "result in substantial or undue economic hardship to the defendant's livelihood and that the defendant has the ability to properly care for all livestock in his or her possession."

To clarify AB 1117, the definition of "livestock" references Section 14205 of the Food and Agricultural Code, which states, "Livestock" includes all animals, poultry, and bees, and aquatic and amphibian species which are raised, kept, or used for profit. It does not include those species which are usually kept as pets, such as dogs, cats, and pet birds.

It was my intent, in using this definition of "livestock," that owners of for-profit horse breeding operations would be included. Owners of horse breeding operations may breed and care for horses ranging in age, and while all owned horses play a role in the for-profit business entity, individual horses may not be of a profit-generating age. It is my intent to clarify that if a horse breeder maintains a for-profit breeding business but at any point in time owns horses that are not of a profit-generating age, the horse breeder would still qualify as an owner of "livestock," as defined in AB 1117.

Legislative Intent—Senate Bill No. 470

Dear Mr. Wilson: SB 470 is a bill to continue a three-decade old Salmon Stamp program. Under the bill, salmon fishermen pay a fee based on their previous year's landings. The funds go to the Department of Fish and Game Fish and Game Preservation Fund and are used for salmon hatchery and salmon habitat restoration projects.

In recent years because of poor salmon catches and fishery closures, revenues from the sale of Salmon Stamps have been minimal, in some years as low as \$50,000. These small amounts still must be administered by the Department of Fish and Game, but administration overhead relative to revenues have been high, so the Department has had to shift funds from other accounts to supplement administrative costs for the Salmon Stamp program.

The current program has is a 3.3% ceiling for administrative costs. SB 470 raises that ceiling to 15% in order to ensure that there are enough funds to do the job without taking funds from other accounts in low revenue years. However, it is my intent to keep administrative costs low and not to give permission to the Department to use this provision to spend beyond what is absolutely required for administrative purposes.

In order to ensure that administrative costs are kept low, my bill has two built-in controls:

First, SB 470 requires the Department to annually post on its website an accounting of how Salmon Stamp revenues are spent, whether for administration or projects. This transparency, by itself, will help keep wasteful spending down.

Second, funds for the program are not continuously appropriated, as in previous years. According to SB 470, funds must be appropriated by the legislature each year. The legislature will carefully monitor the Department's expenditures of Salmon Stamp funds, and taking action if administrative costs seem overly large.

Commercial salmon fishermen are the biggest supporters of SB 470's, and it is my intent to ensure their hard earned money that goes into the Salmon Stamp program is appropriately spent on programs that will increase salmon populations, and that the Department keep administrative costs as low as possible.

Dear Mr. Wilson: This letter is to confirm the Franchise Tax Board's authority, under specified circumstances, to set aside federal administrative interpretation of federal law despite California's long standing effort to conform to federal tax law. Where state law conforms to federal law, state law provides that temporary and final regulations issued by the Treasury Department apply to California, unless the regulations conflict with state law or state regulations. In 2008, the Treasury Department issued Notice 2008-83, which allowed banks, after an ownership change, to take full advantage of losses on loans and bad debts. This was done despite the Treasury Department's lack of authority to substantively change Internal Revenue Code Section 382, a 22 year old tax law limiting the use of losses by banks following an acquisition. This notice was corrected in 2009, but implementation could have had severe consequences on California's tax revenue without an opportunity to be heard by the legislature.

The issuance of Notice 2008-83 highlighted the risks of conforming to federal administrative guidance. Therefore, I hereby submit this Letter to the Journal to confirm the Franchise Tax Board's authority to find a federal income tax regulation, rule, notice, or other administrative interpretation inapplicable for California tax purposes if the federal regulations and administrative interpretations conflict with state law or state regulations.
