Speaker Pérez, on behalf of Assembly Member Mitchell and the Legislative Black Caucus, welcomed special guest, Mrs. Rachel Robinson, widow of civil rights icon and legendary baseball hero, Jackie Robinson.

In 1947 her husband, Jackie Robinson, broke the color barrier in Major League Baseball which had segregated the sport for more than 50 years.

Mrs. Robinson was a native of Los Angeles and a student at UCLA when she met her husband. Together they raised a family. She pursued her career in psychiatric nursing and has held positions at Yale's School of Nursing as an Assistant Professor and at the Connecticut Mental Health Center as Director of Nursing.

In 1973, Mrs. Robinson founded the Jackie Robinson Foundation (JRF), a premier education and leadership development program which equips scholarship recipients with a comprehensive set of support services including internship placement, career guidance, and a myriad of practical life skills. The Jackie Robinson Foundation enjoys a nearly 100% graduation rate, more than twice the national average for minority students.

Mrs. Robinson holds many honors, including the UCLA Medal, for her lifetime achievements.

I am returning Assembly Bill No. 902 without my signature.

This bill doubles the fine for failing to comply with a specific traffic law. That law requires a motorist to slow or move away from an emergency vehicle stopped on the shoulder or median. The new fine, with penalties, would be \$490 instead of \$238.

No showing has been made that piling on an additional \$252 will protect anybody. This enhanced amount strikes me as more punitive than deterrent.
