Dear Ms. Parker: This letter is to clarify the intent of Section 3 of AB 457 (Santiago, 2021), which amends the Section 650 of the Business & Professions Code (BPC). The intent of this section is to clarify that the use of online provider directory and patient scheduling software does not constitute a “patient referral.” Section 3(h) is not intended to prevent entities who provide patients with information, resources, and access to providers from continuing to provide these services.

Existing law provides for the licensure and regulation of various healing arts professions and vocations by boards within the Department of Consumer Affairs. Under Article 6, Section 650 of the BPC, it is unlawful for healing arts licensees, except as specified, to offer, deliver, receive, or accept any rebate, refund, commission, preference, patronage dividend, discount, or other consideration, in the form of money or otherwise, as compensation or inducement for referring patients, clients, or customers to any person, subject to certain exceptions.

Since Section 650 of the BPC was written, technology has changed the way that patients access care in ways that were not envisioned at the time, such as internet-based advertising, appointment booking, and information services, which patients may use as a resource to independently find and access care. Section 3(h) of AB 457 would amend Section 650 of the BPC to reflect modern practices. Specifically, it clarifies that these types of services “shall not constitute a referral of

a patient if the internet-based service provider does not recommend or endorse a specific licensee to a prospective patient.” Section 3(h) is intended to clarify that this activity is permitted under the law, and not to prevent online telehealth platforms from connecting patients to providers.

It is in California’s best interest that telehealth continues to flourish beyond the pandemic, while protecting patient choice and local provider participation.

Dear Ms. Parker: AB 1201, as amended on September 3, 2021, expands the content and labeling requirements for compostable products. Among other things, it amends Section 42357 of the Public Resources Code to provide as follows:

“By January 1, 2024, the department, through a public stakeholder process, shall determine whether, for purposes of this section, it would be feasible to separate the collection of products in order to recover organic waste that is suitable for use in organic agricultural applications from the collection of products not suitable for use in organic agricultural applications. If the department determines that such bifurcation is feasible and would enable efficient processing by solid waste processing facilities, the department shall adopt regulations on or before January 1, 2026, to establish a bifurcated approach, and products that are not collected for the purpose of recovering organic waste that is suitable for use in organic agricultural applications shall comply with the department’s regulations and are not subject to the requirements of this subparagraph.”

This bill and this provision are designed to expand content and labeling requirements for compostable products, not adopt new regulations requiring a bifurcated organic waste collection and processing system.

It was brought to my attention, after the amendment deadline, that this language could be construed to invest CalRecycle with authority to adopt new regulations requiring a bifurcated organic waste collection and processing system.

It is not the intent of the Legislature that AB 1201, specifically the additions to Public Resources Code Section 42357(g)(1)(B), require CalRecycle to modify their newly-adopted organic waste recycling regulations and impose a completely new dual stream collection system for organic waste. The only intent of this provision was for CalRecycle’s feasibility determination to trigger a requirement to adopt regulations to establish a bifurcated approach *to product labeling*.

To the extent that AB 1201 could be construed to grant CalRecycle broader authority than outlined above, I am clarifying that the language in the bill is intended only for CalRecycle, after a public stakeholder process and a feasibility determination to focus its efforts on establishing a bifurcated approach to product labeling, and does not provide authority to adopt new regulations requiring a bifurcated organic waste collection and processing system.

I commit that in 2022, I will seek to amend this statute to clarify this intent and address this unintended consequence of AB 1201.

In addition, the definition of “desirable organic wastes” in section 42357(g)(1)(E) of the Public Resources Code is meant to include products which are intentionally collected by local governments and private solid waste service providers who provide organic waste

collection services to residential and commercial customers in the state. Products associated with the recovery of desirable organic wastes would include compostable bin liners for the collection of yard trimmings or other green materials, food scraps, foodservice packaging that will be collected with uneaten food, and produce stickers, but would not include packaging for organic wastes that are generally not allowed in residential compost program, including pet waste.

Dear Ms. Parker: I am sending this letter in order to clarify my intent of Assembly Bill 1506 (Chapter 326, Statutes of 2020) in order to ensure the bill's successful implementation.

The first component of the bill requires the Department of Justice (DOJ) to investigate all officer-involved shootings (OIS) resulting in the death of an unarmed civilian, and the second requires the Attorney General to review that investigation and, if appropriate, bring criminal charges. My intent was for the DOJ to generally work in *collaboration* with the appropriate local law enforcement agencies rather than be responsible for conducting the entire investigation on its own.

Under AB 1506, DOJ is required to investigate these shootings. However, it was my intent that the initial processing of the scene be generally handled by the local law enforcement agency, and that DOJ would jointly investigate the incident with local law enforcement, taking into consideration any existing County Memorandum of Understanding. Thus, it was my intent that DOJ investigate with assistance from local law enforcement, but it has the discretion to be the primary or only investigative agency involved.

I foresaw that once the investigation is complete, the Office of the Attorney General will review and analyze all reports and evidence to determine if criminal charges are warranted to be sought against the involved law enforcement officer(s). If charges are warranted, the Office of the Attorney General is authorized to be the prosecuting agency. Because of the importance of these matters to those involved and to the public, it was my intent that the Attorney General complete the review as quickly as possible, consistent with the primary goals of conducting a thorough, careful, and objective evaluation of the facts and applicable laws.

My overall intent of AB 1506 is to create a fairer and more transparent process for officer-involved shootings, and to build and strengthen trust among law enforcement and the communities they serve. Thank you for the opportunity to clarify the above provisions.
