#### **PRAYER**

Upon invitation of Speaker pro Tempore Lowenthal, the following prayer was offered by Reverend Patti Oshita:

Bob and I took my mom and dad on their first trip back east, in August of 2001. The concierge at the hotel who helped us immensely, encouraged us to visit the World Trade Center. Remembering his recommendation, one day we taxied to there. He said it had a spectacular view of New York City. When we arrived, it was drizzling rain with thick dark clouds. Looking up, we could barely see the 4th floor; so we decided to make it a day of shopping.

Later, when the concierge saw us, he came running over to ask us about our World Trade Center experience. We explained it was so cloudy and overcast that we decided not to go to the top. He looked so disappointed. He said, "On days like today, the view is special! From the 110th floor, you are above the clouds. The sun is shining . . . and looking down, you can see the tops of skyscrapers popping up here and there, all round you, through the clouds. It's amazing . . . even magical!" He encouraged us to go the next day. Sadly, I told him, "We are leaving tomorrow." But added, "For sure we will go to there the next time we are in New York!" This was in August of 2001. Just weeks later, on September 11th, we all watched in horror as the twin towers of the World Trade Center were struck by hijacked airliners and collapsed in flames. We knew, without being told, that there were thousands of victims.

For weeks I was numb with disbelief, wondering, "How could this happen? Why is there so much hate in the world?" As a lifelong advocate for peace, I worried, "Is there hope for world peace?" But the words of a wonderful teacher, Rev. Gyomay Kubose, grounded me. He would encourage, "world peace begins with me." The end of anger, hate and violence begins with me. It begins with my acts of kindness and understanding. We may not be able to change the whole world, but our acts of kindness can impact people around us. Each act is a ripple of goodness. And our collective actions can become a wave of kindness, that can help calm the anger and diminish the hate that detonates every bomb and fires every deadly bullet.

Namo Amida Butsu—Let us live with kindness and gratitude beyond words.

## Legislative Intent—Assembly Bill No. 339

September 3, 2025

Sue Parker Chief Clerk of the Assembly State Capitol, Room 319 Sacramento, California

Dear Ms. Parker: I write to express my intent in authoring Assembly Bill (AB) 339 related to Local Public Employee Organizations Notice Requirements. AB 339 requires local agencies to provide recognized employee organizations with no less than 45 days' written notice before issuing requests for proposals, quotes, or renewing contracts for services within the scope of work of represented job classifications.

Under existing law, the Meyer-Milias Brown Act, public agencies have, in most circumstances, an obligation to meet and confer with recognized employee organizations about plans to contract out bargaining unit work. This bill does not create a new obligation for employers, but rather places a timeline on an already existing process. An explicit requirement for at least 45 days' advance notice will make the existing meet and confer process more meaningful. AB 339 does not apply to all public contracts, only to contracts for services within the scope of job classifications represented by the recognized employee organization. AB 339 also has an exemption for contracts for alteration, demolition, installation, construction, repair, maintenance work that is subject to the state prevailing wage law, and for contracts related to the planning, design, or management of public infrastructure and building projects.

AB 339 includes provisions for emergencies and exigent circumstances in subdivision (c). This exception is applied only in genuine emergencies and urgent situations that could not reasonably have been anticipated. This provision does not seek to provide public agencies with a routine mechanism to circumvent the 45-day notice requirement. Rather, "emergency" refers to sudden, unforeseen circumstances posing immediate threat to public health, safety, or welfare. "Exigent circumstance" refers to urgent situations beyond the agency's reasonable control requiring immediate action to prevent significant harm to public operations, finances, or community wellbeing, including sudden financial crises threatening essential services or system failures requiring immediate response. Consistent with the Public Employment Relations Board's (PERB) interpretations of employer bargaining obligations, this exception does not apply to situations resulting from poor planning, foreseeable budget cycles, or routine operational decisions that could have been anticipated, including long-planned reductions in force, budget shortfalls known in advance, or delayed responses to expiring contracts.

AB 339 applies only to contracts within the "scope of work of the job classifications represented by the recognized employee organization." This phrase must be interpreted practically and in the context of existing collective bargaining relationships. The phrase applies to situations in which contracted services substantially overlap with or could reasonably be performed by existing represented employees within their established job classifications and skill sets.

If disputes should arise regarding whether contracted services are within the scope of work classifications, PERB maintains established procedures for resolution. If a recognized employee organization believes that contracted work falls within scope of their represented classifications and that the agency failed to provide proper notice under AB 339, the union may file an unfair practice charge with PERB. PERB's existing dispute resolution framework provides the appropriate forum for adjudicating disagreements about whether specific contracted services trigger the notice requirements of this bill, should any such disputes arise. If there are situations in which the answer is unclear, the public agency can simply give the employee organization written notice of its plans, rather than engage in a prolonged dispute.

This clarification is entered into the Journal to ensure that the application of AB 1414 is interpreted consistent with its purpose and scope as intended by the author.
