I am signing Assembly Bill 1014, which will require the Director of the Department of Boating and Waterways to appoint an Abandoned Vessel Advisory Committee to assist the Department in making recommendations to the Legislature on or before January 1, 2005, on strategies to prevent the abandonment of recreational vessels. This legislation provides that members appointed to this Advisory Committee will serve without compensation or reimbursement by the State.

I am signing this legislation because preventing the abandonment of vessels will protect the environment from the spill of fuel and other hazardous materials into our waterways. #### Clarification—Senate Bill No. 18

September 12, 2003

Mr. E. Dotson Wilson Chief Clerk, California Assembly State Capitol, Room 3196 Sacramento, California

Dear Dotson: There has been a request for clarification of Section 21097(i) and (j) of the Public Resources Code as contained in SB 18. Differing opinions as to their potential meaning have been presented to the Legislature.

In subdivision (i), the NAHC may make a final determination that a proposed project will result in a substantial adverse change to a TTCS. If the consulting parties do not agree on project changes or mitigation measures, the NAHC may recommend project changes or mitigation measures to the lead agency, which must consider the recommendation.

Certain tribal, local government and construction representatives were concerned that, in its implementation and interpretation, this section might be read to require the lead agency to follow the recommendation of the NAHC without the lead agency exercising the lead agency's independent judgment in determining the feasibility of project changes or mitigation measures pursuant to 21097(i). This letter is intended Section to prevent that misunderstanding. In considering the recommendations of the NAHC, the lead agency shall exercise its independent judgment and, if it determines that the recommended project changes or mitigation measures are not feasible, the lead agency may not adopt them.

With respect to subdivision (j) of Section 21097, this section provides the criteria by which local lead agencies may approve or carry out a project when adopting a statement of overriding considerations. Subdivision (j)(2) applies to projects located on state lands or federal lands managed by the state that will result in a substantial adverse change to TTCS. Subdivision (j)(1) applies to all other projects. Tribal, local government and construction industry groups were concerned that, in its implementation and interpretation, this subdivision might be read to only permit findings provided in Section 21081, subdivision (b), of the Public Resources Code. This letter is intended to clarify that for projects on private land, subdivision (j)(2) does not apply and a public agency approving or carrying out a project shall be subject to the requirements of Section 21081, including subdivision (a) of Section 21081, and subdivision (j)(1) of Section 21097; projects on private land shall not be subject to the more limited override provisions of subdivision (j)(2).

Dear Mr. Wilson: I am writing this letter to clarify my intent regarding Assembly Bill 715, dealing with the marketing use of personal health information by health care providers, health care service plans and their contractors. I request that this letter be placed in the Journal as a matter of record.

This bill amends the Confidentiality of Medical Information Act to provide that health care providers, health care service plans and their contractors are prohibited from using personal health information for marketing purposes. However, AB 715 specifically excludes certain communications from the definition of marketing, including communications that are tailored to the circumstances of a particular individual to educate or advise the individual about their treatment options and otherwise maintain the individual's adherence to a prescribed course of medical treatment. This exemption is limited to chronic and seriously debilitating or life-threatening conditions as defined in subdivisions (d) and (e) of Section 1367.21 of the Health and Safety Code. This code section defines "chronic and seriously debilitating" as diseases or conditions that require ongoing treatment to maintain remission or prevent deterioration and cause significant long-term morbidity.

It is my intent with respect to this bill that the definition of chronic and seriously debilitating or life-threatening apply to both physical and mental diseases or conditions.

#### Legislative Intent—Assembly Bill No. 786

Dear Mr. Wilson: Assembly Bill 786 would require the County of San Mateo, on a pilot project basis, to adopt the Minimum Data Set-Home Care (MDS-HC) assessment instrument for use by home- and community-based programs in San Mateo County that serve elderly and disabled persons. This bill would provide that state funds shall not be appropriated for its purposes.

Many home- and community-based health programs receive funding from State-administered programs that use federal funds, such as the Medi-Cal program, and must comply with federal requirements to maintain eligibility for federal funding. The federal government will sometimes modify those requirements, upon request by the appropriate State agency. If a federal agency requires submission of a federal Medicaid waiver for implementation of AB 786, the Department of Health Services would incur substantial costs for preparation of that request. This would create an inconsistency because AB 786 requires that no State funds be appropriated for its purposes.

To avoid this inconsistency, I am clarifying, by this letter, that implementation of this bill will be terminated if a federal agency requires the Department of Health Services to submit a federal Medicaid waiver as a condition for implementation of AB 786.

I ask that this letter be included in the Assembly Journal.

Dear Speaker Wesson: I respectfully request this letter be entered into the Assembly Journal to clarify the record as to one point relative to SB 709 that I authored, as it was considered and acted upon on the Assembly Floor.

Section one of the bill creates Section 40606 in the Health and Safety Code and authorizes the San Joaquin Air Pollution Control District board to monitor emissions from all stationary agricultural pumps in the district. This would include those that might be designated by the federal Environmental Protection Agency as "nonroad" engines that are subject to the requirements of Title II of the federal Clean Air Act (42 U.S.C. Sec. 7521 et seq.).

The intent of this section is to allow the district to monitor and measure emissions from all agricultural pumps. However, I understand that with the passage of SB 700, the district will have the authority to require operating permits for all internal combustion engines used at agricultural operations, except an engine that is used to propel implements of husbandry. This would make Section 40606 of SB 709 unnecessary and duplicative.

If SB 700 is passed by the legislature and signed by the governor, it is my intent that Section 40606 of the Health and Safety Code enacted by SB 709 will be null and void.

Dear Speaker Wesson: I respectfully request this letter be entered into the Assembly Journal to clarify the record as to two points relative to SB 700 that I authored, as it was considered and acted upon on the Assembly Floor.

1. Section 2 of the bill adds Section 39011.5 to the Health and Safety Code relative to the definition of "agricultural source of air pollution". Amendments to this section of the bill on September 9, 2003, include the insertion of a new subsection (b) to read: (b) Any district rule or regulation affecting stationary sources on agricultural operations adopted on or before January 1, 2004, is applicable to an agricultural source.

The purpose of this amendment is to clarify that rules proposed by an air district regarding stationary sources of air pollution on agricultural operations adopted by January 1, 2004 apply to those agricultural sources within the district that adopts the rule or regulation.

2. Language in amendments made to the bill on September 9, 2003, in Sections 40724.6 (c)(1), 42301.16 (b)(2), 42301.16 (c)(2), refer to the showing by an air district that air pollutants "cause or contribute to a violation of a state or federal ambient air quality standard".

The intent of these sections is to ensure that each district, in its permitting of agricultural sources, is required to use the same standards in evaluating regulatory actions on agricultural sources of air pollution that it uses when evaluating regulatory actions on other sources of air pollution. Specifically, each district's showing shall be consistent, with its showing for other source categories as it involves the district's determination of the significance of the emissions in causing or contributing to a violation of an ambient air quality standard, the technical and practical feasibility of reducing such emissions, the cost-effectiveness of the options for emission reductions, and the need for, and effect of requiring such sources to obtain permits.

Because of this intent, and the late date to which the amendments were made, I am proceeding with this legislation with the intent and understanding that the district rule applicability and consistent standards will be applied in implementation of the appropriate sections of this legislation.

Dear Mr. Speaker: I respectfully submit for your consideration, this letter for the Assembly Journal with respect to the intent of the addition of Section 25249.2 of the Health and Safety Code in the September 2, 2003, version of my AB 826, dealing with perchlorate reporting requirements. This language requires certain perchlorate facilities, as defined, to submit to the California Environmental Protection Agency, on or before July 1, 2004, a summary report of any subsurface and any groundwater monitoring, investigation, or remediation work that has been performed at the facility with regard to perchlorate.

It is not my intent to require double reporting of this information by facilities already under order to submit such information to the federal, state and local regulatory agencies. The California Environmental Protection Agency, including the affected agencies within its jurisdiction, the State Water Resources Control Board and the Department of Toxic Substances Control, have indicated that they would not expect such facilities to double report, but merely provide a letter by the compliance date that similar information has been included in response to an order issued by a regional water quality control board pursuant to Division 7, Chapter 5 of the Water Code, or an order,

consent order or consent decree issued or entered into by the department pursuant to Division 20, Chapter 6.8 of the Health & Safety Code. The letter should then merely identify the subject order.

Similarly, the facility should not be required to doubly submit similar information that is reasonably available to the California Environmental Protection Agency. Therefore, if a facility believes the document is reasonably available, it may identify by letter similar information contained in an order, consent order or consent decree issued or entered into by the United States Environmental Protection Agency pursuant to the Federal act, as that term is defined in Health and Safety Code sections 25115.1 and 25315. However, the California Environmental Protection Agency may require the facility to submit that information if it determines that such information is not reasonably available.

This letter is submitted to the journal to clarify my intent rather than to seek amendments to this measure at this late date in the process this year. Thank you for your assistance in this matter.

Legislative Intent—Assembly Bill No. 1082

Dear Dotson: This letter is to clarify the purpose of AB 1082 as to the application of the bill. At present, the bill is in Enrollment.

The purpose of adding subdivision (b) to Section 22869 was to allow a subset of local contracting agencies that currently contract with the California Public Employees' Retirement System (CalPERS) to provide health insurance benefits to their employees. Prior to January 1, 2000, these agencies adopted policies recognizing an employee's domestic partner for the purpose of providing health insurance benefits to that partner. These policies recognized both same and opposite-sex domestic partnerships. Moreover, they did not require the members of the opposite-sex domestic partnerships to be over a certain age but, like all domestic partnerships recognized by the policies, did require that they file a document with the agency attesting to their partnership. Through my research, I have determined that there are at least six local contracting agencies that fall within the bill's provisions. They include the City of Cathedral City, the City of Palo Alto, the City of Santa Cruz, the City of West Hollywood, the County of Santa Cruz and the Santa Cruz Metropolitan Transit District.

On January 1, 2000, AB 26 (Chapter 588, Statutes of 1999) became effective. AB 26 authorized local contracting agencies the option to offer domestic partner health insurance benefits to their employees through the CalPERS program but restricted this option to those employees that met the domestic partnership definition contained in Family Code section 297, i.e., same-sex couples or opposite-sex couples

where both partners are over the age of 62. AB 25 (Chapter 893, Statutes of 2001) subsequently amended this definition to require that at least one of the partners be over the age of 62.

AB 1082 will allow those few qualifying local contracting agencies the option to provide CalPERS health insurance coverage to the opposite-sex domestic partners where both partners are under the age of 62, provided that a local definition was adopted prior to January 1, 2000.

AB 1640 was the product of consensus negotiations among the regulated community, state agencies and local agencies, and I am supportive of measures developed by consensus. Indeed there have been several measures passed this year relating to the Underground Storage Tank Program as well as the CUPA program.

The Unified Hazardous Waste and Hazardous Materials Management Regulatory Program consolidates and coordinates under the California Environmental Protection Agency the management of hazardous waste, hazardous materials and underground storage tanks. That Act authorizes the certification of local agencies (both CUPAs and local designated officers) to assume responsibility for enforcement of elements of the program. One of the six programs that are brought together under the unified system is the underground storage tank programs.

While it is not my intention to comment on any particular aspect of the legislation passed in this legislative session, I did want to state for the record that, in my capacity as Chair of the Environmental Safety Committee, I intend in the upcoming months to examine the "chain of command" elements between the state and local levels for the underground storage tank program to make sure that oversight roles and boundaries of responsibility are clear and traceable.

Fully recognizing that Proposition 215 cannot be amended by the Legislature, we have resisted all efforts to make the new identification card system created by SB 420 mandatory—and at least two times SB 420 contains specific language declaring our intent that this program is wholly voluntary.

In addition, the guidelines in SB 420 establish permissible amounts that are intended to be the threshold, and not a ceiling.

Furthermore, SB 420 specifically allows localities with higher possession or cultivation amounts to retain them, and other local jurisdictions to establish new guidelines to exceed what has been set forth in this bill. No jurisdiction may establish amounts lower than those set forth in SB 420.

Altogether, we believe that our final version of SB 420 is the very best we could hope to get enacted into law and that it provides (pursuant to the California voters' will in enacting Proposition 215) broad protection to tens of thousands of ill Californians without jeopardizing any ill Californians.

I respectfully request this letter printed in the Assembly Journal for the purpose of clarifying the intent of AB 1762 (Committee on Budget). AB 1762 chaptered by the Secretary of State on August 11, 2003, contains numerous statutory changes pertaining to state health care programs. Among these changes is the imposition of a quality improvement fee on the capitation payments paid to Medi-Cal managed care plans for enrolled Medi-Cal beneficiaries (Section 73, Welfare & Institutions Code Section 14464.5 (b)). While the fee would be imposed on an annual basis, it would be paid to the state monthly.

Pursuant to subdivision (c) of Section 14464.5, it is the responsibility of the Department of Health Services to implement this section in a manner that complies with federal requirements. The earliest the department can commence collection of the fee, pursuant to subdivision (k), is January 1, 2004. However, the fee will not be assessed or collected if the department does not comply with various federal requirements for federal matching funds.

While it appears unlikely that the Department will be granted federal approval from the Centers for Medicare and Medicaid Services (CMS) for this purpose, the language of the bill states that the Department can begin collecting the quality improvement fee on January 1, 2004.

Therefore, it is the intent of the budget committee that no fees be collected by the Department until CMS approves federal participation in the quality improvement fee or requires the state to collect the fee.

As it is certain that additional budget cuts will impact health services, environmental protections, local governments and public safety issues, I commit to you that the Budget Committee will be evaluating all options for spending reductions, revenues, and fees.

Through special session legislation, the recently enacted 2003 Budget Act (Chapter 157, Statutes of 2003) as well as its corresponding trailer bills, new fees have been imposed and others increased. Specifically in the areas of natural resources and environmental protection, these fees have provided support for various departments who have been faced with significant General Fund cuts. Given these cuts, as well as the breadth of individuals and businesses assessed these fees, I am committed to ensuring that any new fees be spread fairly, based both on costs of delivering state's services and the actual impacts on the environment, public health, and safety.

While many options for increased revenue from fees were evaluated during this first year of the 2003–04 session, many others remain on the table and deserve a full vetting by the Legislature prior to the final

approval of the 2004 Budget Act. Therefore, I will be working with the Chair of the Assembly Budget Subcommittee to ensure that, as part of its duties, the subcommittee will be reviewing California's environmental fee structure. This review will include an emphasis on hazardous waste fees and other similar fees that have not been reviewed in recent years.

Dear Dotson: This letter serves to clarify legislative intent regarding Section 5 of my AB 231, a bill to reduce hunger in California by removing barriers to participation in the federal food stamp program. One of the barriers that has been identified is a face-to-face "in office" interview, as many working people find it difficult to leave their jobs or find transportation to be interviewed at the welfare office.

It is the intent of the Legislature to increase utilization of current law hardship exemptions from the face-to-face interview, when appropriate, without creating an undue burden on administrators of the Food Stamp Program. To that end, I have been working with advocates, the County Welfare Directors Association, and the state Department of Social Services to develop a process. I would like to clearly state for the record our intention on how this process, created in Section 5 of the bill (Welfare and Institutions Code §18901.10), would work.

Our intention is to require counties to cursorily consider an applicant/recipient's need for a face-to-face interview exemption during the intake process. Our expectation is that the county and the applicant will be able to move toward agreement on an interview location or interview alternative. Only if a satisfactory accommodation between the county and applicant/recipient cannot be worked out, would the county evaluate whether the household qualifies for an exemption. We believe this cursory consideration, followed by an evaluation only where an agreement has not been achieved, is the least burdensome process that would still lead to a reduction of the use in office interviews.

Dear Mr. President and Mr. Speaker: We write to clarify our pending legislation, SB 614 and AB 1601, related to abusive tax shelters. We have made substantial concessions in these measures to address criticisms by interested parties. We have agreed to clarify certain points in this letter.

The bills have been amended to limit the applicability of the penalty for "noneconomic substance" transactions. It is our intent that the Franchise Tax Board rely upon the common law economic substance doctrine and that the penalty language contained in this section shall not be adopted by a court as a substantive definition other than for purposes of the penalty.

Amendments were also made to the tax shelter reporting requirements. It is our intent that the authority granted to the Franchise Tax Board by AB 1601 and SB 614 to identify and publish for California income or franchise tax purposes "listed transactions" (as defined under subdivision (a) of Section 18407 of the Revenue and Taxation Code) does not apply to transactions occurring prior to September 2, 2003. It is also our intent that the new reporting requirements apply to any transaction entered into on or after February 28, 2000, that becomes a "listed transaction" for federal income tax purposes at any time (as defined under subdivision (a) of Section 6011 of the Internal Revenue Code).

Finally, the bills have been amended to make all penalties affected by the bills apply to abusive tax shelter transactions only.

Among the exemptions from the definition of "qualified contract" are contracts with providers enrolled in the Medi-Cal program pursuant to Article 1.3 (commencing with Section 14043) of Chapter 7 of Part 3 of Division 9 of the Welfare and Institutions Code and health facilities that provide services to Medi-Cal patients.

Due to the fact that these providers and health facilities may also serve the Medi-Cal program through their contracts with prepaid health plans that contract with the Department of Health Services to provide services to Medi-Cal beneficiaries, it is the intent of AB 1093 that a contract with a provider, as described in Section 10480 of the bill [paragraph (2) (G) of subdivision (c)], includes contracts between the Department of Health Services and prepaid health plans.

Specifically two similar, but conflicting, sections were added to AB 1548 dealing with alignment of education materials to State Board of Education statutory requirements. Public Resources Code Section 71304(d) was incorrectly added to AB 1548. The correct section, Public Resources Code Section 71300(g), was also added on September 3, 2003. This section correctly requires that any instructional materials for use in elementary or secondary public schools produced as a result of AB 1548 comply with State Board of Education requirements contained in Chapter 1 (commencing with Section 60000) of Part 33 of the Education Code, including reviews for legal and social compliance. The predicament is that these two sections conflict with each other and gives different direction to the Secretary for Environmental Protection and California Integrated Waste Management Board for implementing this bill.

Next year I plan to introduce legislation to fix this problem by repealing Public Resources Code Section 71304(d). Until this change can be accomplished legislatively, I would ask the Secretary for Environmental Protection and the California Integrated Waste Management Board to implement AB 1548 as directed in Public Resources Code Section 71300(g).
