Members of the Assembly: As required by the Housing and Safety Code, Division 31, sections 53533 and 53545, the Bureau of State Audits presents its audit report concerning the first audit in a series on the Housing and Emergency Shelter Trust Fund acts of 2002 and 2006.

This report concludes that the Department of Housing and Community Development (department) and the California Finance Housing Agency generally awarded funds in a timely manner and consistent with the law. However, we noted that the monitoring of awardees performed by the department is inconsistent. In addition, the department overrode controls over advances put in place for one of the programs tested. Further, for two of the programs we reviewed, the

department had not established monitoring processes for the completion phase of its agreements with awardees. Strengthening its oversight in these areas would help the department ensure that awardees have used funds only for eligible costs and that their activities benefit only targeted populations.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the funding and approval process required for grade separation projects by state and local transportation agencies.

This report concludes that although the Public Utilities Commission's (Commission) priority list of grade separation projects for the last several years has contained more than 50 projects, the California Department of Transportation has been unable to allocate all of the Grade Separation Program funds because local agencies have often not taken the additional steps necessary to apply for the funds once their projects are included on the Commission's priority list. Part of the reason for this failure to apply for funds is that the cost of grade separation projects has increased more than tenfold over the past 30 years while the funds available from the Grade Separation Program have remained unchanged. Specifically, the average cost of a grade separation project has increased from \$2.5 million in 1974 to a current average of just more than \$26 million. Local agencies say they are experiencing difficulties securing the funding necessary to pay for their share of grade separation projects; thus, some are not nominating new projects to be included on the Commission's priority list and many are not applying for funds for the projects already on the priority list.

A report prepared by the Commission in March 2007 showed that \$165 million is needed to provide funding for the same number of grade separation projects that \$15 million provided in 1974. Additional funding will be available for grade separation projects from a bond measure approved by California voters in November 2006, which will

provide a one-time amount of \$250 million to improve railroad crossing safety. The bond measure makes \$150 million of these funds available for allocation under the process established for the Grade Separation Program.

Members of the Assembly: Pursuant to the California Whistleblower Protection Act, the Bureau of State Audits presents its investigative report summarizing investigations of improper governmental activity completed from February 2007 through June 2007.

This report details nine substantiated allegations in several state departments and universities. Through our investigative methods, we found waste and misuse of state funds and resources, incompatible activities, a conflict of interest, and other improper activities. For example, our investigation found that the California Highway Patrol wasted \$881,565 in state funds when it purchased 51 vans and allowed nearly all of them to sit idle for more than two years.

In addition, this report provides an update on previously reported issues and describes any additional actions taken by state departments to correct the problems we previously identified. For example, the Department of Conservation reported that when it pursued adverse action against an employee who engaged in improper acts, the employee resigned. It further reported that it is currently pursuing adverse action against the employee's manager who also engaged in improper acts.
