RE: Bargaining Unit 5, California Association of Highway Patrolmen (CAHP) Compensation Survey

The attached Bargaining Unit (BU) 5, CAHP compensation survey was prepared pursuant to Government Code (GC) Section 19827 and the terms of the BU 5 Memorandum of Understanding (MOU). The survey measures compensation for California Highway Patrol (CHP) Officers as compared to their counterparts in five local jurisdictions.

The 2024 survey resulted in a four percent (4.0%) lag, indicating their compensation was below the weighted average compared to their surveyed counterparts. Therefore, under GC and the terms of the BU 5 MOU, effective July 1, 2024, rank and file CHP officers will receive a 4.0% salary increase. Pursuant to GC Section 19849.18, excluded and exempt employees related to BU 5 will also receive the 4.0% salary increase. Funding has already been approved by the Legislature and the Governor as part of the 2024–25 Budget Act.
