Dear Republican Colleagues: Thank you for your letter requesting a reconvening of session under Joint Rule 52(b).

The people of California deserve action on the issues, but reconvening session would not offer them substantial, immediate benefits. The Legislature devoted significant time and resources to these very issues in the recently completed session, which included providing rebates to help with the cost of fuel and consumer goods. Those funds are landing in bank accounts as we speak—that's real, tangible aid for millions of Californians, and we will continue to examine other ways to help individuals and families when we reconvene.

As you are aware, calling the Senate and Assembly back at this time would not provide Californians with quick relief, since the California Constitution does not allow us to send bills to the Governor after November 15, less than two weeks away.

We welcome and echo your concerns regarding gas prices, and look forward to working with you in the Special Session called by the Governor to address excess oil producer profits.
