INTRODUCTION OF ASSEMBLY BILLS

The following bills were introduced:

ASSEMBLY BILL NO. 2—Anderson, DeSaulnier, and Jones. An act to amend Sections 703.150 and 704.730 of the Code of Civil Procedure, relating to judgments.

ASSEMBLY BILL NO. 3—Villines. An act to amend Section 6 of Chapter 761 of the Statutes of 2008, relating to state property.

ASSEMBLY BILL NO. 4—Lieu, De León, and Lieber (Coauthors: Bass and Galgiani). An act to amend, repeal, and add Section 2924 of, and to add and repeal Sections 2923.52 and 2923.53 of, the Civil Code, relating to residential mortgage loans.
