Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report concerning the University of California (university) and its responses to sexual harassment complaints involving faculty and staff harassers and student victims. Title IX of the federal Education Amendments of 1972 (Title IX) requires the university to prohibit discrimination on the basis of sex, including sexual harassment. This report concludes that although the university has been aware of issues with its responses to sexual harassment complaints and has taken steps to address them, it must do more to stop, prevent, and remedy sexual harassment at its campuses.

Notably, we found that the three campuses we visited—Berkeley, Davis, and Los Angeles—took much longer to discipline faculty in the Academic Senate than they did to discipline staff. On average, the three campuses disciplined staff within 43 days after the conclusion of an investigation compared to 220 days for faculty in the Academic Senate. In addition, the three campuses disciplined faculty inconsistently, especially those faculty who were the subjects of multiple sexual harassment complaints. Campus Title IX coordinators, if they had a role in deciding discipline—which they currently do not have—could help the university gain consistency in the discipline it imposes. We also found that the three campuses inconsistently followed Title IX guidance in their informal and formal processes to address sexual harassment complaints. The three campuses frequently exceeded investigation time frames without obtaining approved time extensions and they often did not send all required information to the complainants and respondents.

Finally, the university's Office of the President established a systemwide Title IX office (systemwide office) in February 2017 with a goal to implement a consistent and coordinated response systemwide to complaints of sexual harassment. However, to make the systemwide office more effective, the Office of the President needs to define how much consistency it desires and provide the systemwide office the necessary authority to achieve it. We identified three areas in which the systemwide office should play a central role in the university's efforts to prevent and respond to sexual harassment: setting policy, analyzing applicable data, and overseeing the campuses. Based on feedback from external entities and internal groups, the university has taken steps to improve its response to complaints of sexual harassment, but our audit

found that the university needs to take additional steps to fully resolve the concerns that reviewers have raised.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report of the Department of Rehabilitation's (Rehabilitation) grant process.

Rehabilitation works in cooperation with nonprofit agencies to provide services, such as career education and training, assistive technology, and independent living skills training to individuals with disabilities. This report describes the results of our examination of Rehabilitation's process to solicit grant applications, evaluate applications and award grants, and review any appeals, for a selection of grants awarded to these agencies during fiscal years 2014–15 through 2017–18.

This report concludes that Rehabilitation's inadequate guidance and oversight of the grant process led to inconsistencies and, in certain cases, perceived bias in its evaluations and awards of some grants. Although required to have procedures in place, Rehabilitation failed to formalize a process for soliciting and awarding grants, which resulted shortcomings and inconsistencies. For instance, numerous Rehabilitation did not clearly define the roles and responsibilities of staff involved in the grant process to ensure they knew how to carry out the process. It also did not adequately solicit stakeholder feedback in developing the requests for applications (RFAs) for most of the grants we reviewed, and the RFAs did not always include adequate scoring criteria, or descriptions of the evaluation, award, and appeals processes. Additionally, Rehabilitation's poor records management and it not ensuring that staff complied with its records retention policy contributed to its failure to appropriately respond to some public records requests.

As it relates to the evaluation of applications, we found that Rehabilitation failed to publish solicitations for individuals evaluating the grant applications (evaluators) and ensure they were free from bias and, for one grant, selected evaluators with previous ties to one of the applicants—creating at least the appearance of potential bias. Rehabilitation also failed to demonstrate that it provided adequate training or written instructions to its evaluators to ensure they understood the evaluation process, including how to score grant applications. This contributed to some scoring inconsistencies, and Rehabilitation sometimes convened new evaluation panels to rescore applications without rectifying the issues that caused the inconsistencies in the original scoring. Without adequate oversight of the grant process, Rehabilitation lacks assurance that staff and evaluators adhered to its grant process, and that it can demonstrate the process was followed as intended.

We found that Rehabilitation's grant review committees responsible for reviewing appeals did not adequately review each appeal, such as for potential evaluator prejudice and whether evaluators' scores were supported by evidence, as suggested by its grant manual. Further, regarding an appeal of one grant award, a grant review committee made recommendations to Rehabilitation upon identifying deficiencies in the grant process; however, Rehabilitation chose not to address these recommendations and allowed some errors to persist through the subsequent evaluation and award.

Members of the Assembly: Pursuant to the California Whistleblower Protection Act, the California State Auditor's Office (State Auditor) this investigative report summarizing investigations concerning allegations of improper governmental activities that were completed between July 2017 and June 2018. During this time period, the office received 1,331 calls or inquiries within its investigative jurisdiction and conducted investigative work on 1,481 cases that we opened either in previous periods or in the current period. We determined that 1,018 of these cases lacked sufficient information for investigation or are pending preliminary review. We conducted additional work on the remaining 463, of which 86 resulted in either an independent investigation by our office or a referral to the involved state agency for further investigation.

This report details seven substantiated allegations involving several agencies and two university campuses. Through investigations, we found misuse of state time and property and economically wasteful activities. In total, we identified an estimated

\$200,000 in inappropriate expenditures.

For example, two employees at California State University, Fresno failed to perform their work duties for thousands of hours during a period of at least five years. From 2013 through 2017, these two employees failed to account for more than 5,100 hours by taking extended breaks and leaving campus without permission. This misuse of state time cost the State more than \$111,000 in salary paid for work not performed. In addition, the employees' managers failed to ensure that these two employees performed their work.

In another investigation, we determined that a director of nursing at one of California's adult prisons violated state law by removing a licensed vocational nurse (LVN) from patient care duties and assigning her to perform the duties of an office technician. This resulted in nearly \$30,000 of unnecessary salary payments from May 2015 through July 2016, including overtime payments to other nurses who covered the LVN's assigned post.

State agencies must report to the State Auditor any corrective or disciplinary action taken in response to recommendations made by the State Auditor. Their first report is due no later than 60 days after we notify the agency or authority of the improper activity and monthly thereafter until corrective action is completed.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report concerning San Diego County's Health and Human Services Agency (Health Agency) and whether it has adequate staffing levels of public health nurses (PHNs) to appropriately serve county residents. This report concludes that the Health Agency should measure and assess PHN efficiency so it can better demonstrate that it employs the appropriate number of PHNs to efficiently serve its residents, and that it should better ensure its PHNs are prepared for future public health emergencies.

The Health Agency is responsible for providing a variety of health and social services to county residents, including child welfare, public health, and behavioral health services. San Diego County's Code of Administrative Ordinances requires the Health Agency's director to administer programs through its departments, divisions, and geographic service regions in a manner that integrates the administration and delivery of services to ensure effectiveness, efficiency, accessibility, and quality. We found that the Health Agency does not consistently use available information such as case assignment or caseload data to measure PHN efficiency and help assess its PHN staffing assignments. For instance, the Health Agency does not require its managers to monitor each PHN's caseload. Our review of caseload information for the Health Care Program for Children in Foster Care and the California Children's Services program revealed that the average caseload per PHN exceeded state benchmarks for both programs for the three fiscal vears we reviewed.

In addition, San Diego County experienced an outbreak of hepatitis A in 2017, which the Health Agency detected in March 2017 and for which the county declared a local public health emergency in September 2017. The Health Agency used both its own PHNs and temporary staff, including staff from hospitals and fire departments, to respond to the hepatitis A outbreak. Although the Health Agency appears to have followed its plan for responding to public health threats to address the outbreak, the plan was still in draft form until June 2018. Distributing the plan to its PHNs and training them on its protocols would better ensure that the Health Agency's PHNs understand their responsibilities during future public health emergencies.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report concerning the Toll Bridge Seismic Retrofit Program (seismic program) including work to replace a section of the San Francisco—Oakland Bay Bridge construction project. This report concludes that the State could save millions of dollars annually by mandating oversight and risk management lessons learned from the seismic program.

We found that the effective use of oversight and risk management in the \$9 billion seismic program provides a valuable lesson for the State. In 2005, concerned about escalating costs, the Legislature created the Toll Bridge Program Oversight Committee (Oversight Committee) to oversee the seismic program, and required the California Department of Transportation to develop a comprehensive risk management plan. These two factors minimized delays and controlled costs. For example, Oversight Committee decisions resulted in cost avoidance and savings totaling at least \$505 million. Moreover, comprehensive risk management played a critical role in preventing more than \$455 million in potential costs and seven years in probable delays. With more than \$600 billion in transportation infrastructure projects projected to occur over the next several decades in three of the State's largest metropolitan areas alone, a lack of sufficient oversight and risk management could result in significant delays and cost escalations that taxpayers ultimately would bear. Requiring early oversight committee involvement and risk management plans for major publicly funded transportation projects could mitigate these risks and ensure transparency and accountability throughout California.

Further, we found that the seismic program will end in 2019 roughly on budget at a cost of about \$9 billion; however, maintenance and debt service costs will continue. The seismic program experienced significant cost growth between 1997 and 2005, before additional oversight helped to stabilize the cost. Revenues from tolls on San Francisco Bay Area bridges, as well as debt backed by that revenue, accounts for nearly two-thirds of all funds for the seismic program and will pay for maintenance costs in the future. The Bay Area Toll Authority (Toll Authority) is responsible for administering toll revenues. As of the end of fiscal year 2016–17, the Toll Authority projects that its remaining debt service payments—principal and interest on all of its current bonds—through fiscal year 2055–56 will total \$18.7 billion. The Toll Authority had also projected the possible need for a toll increase in fiscal year 2026–27; however, it will be

reevaluating its projections in light of a recent voter-approved measure to increase tolls to fund a variety of transportation projects.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report concerning the California Department of Resources Recycling and Recovery's (CalRecycle) oversight of California's mattress recycling program (mattress program) as administered by the Mattress Recycling Council (Mattress Council)—a nonprofit entity founded by a mattress industry association and based in Virginia. The State enacted the Used Mattress Recovery and Recycling Act (recycling act) to reduce illegal dumping and increase recycling of mattresses and box springs (mattresses), and to substantially reduce public agency costs for the end-of-use management of mattresses.

This report concludes that CalRecycle has not provided the necessary oversight to ensure the mattress program fulfills its purpose. CalRecycle has missed an opportunity to ensure that the mattress program aligns with legislative intent because it has not established goals in three critical program areas: increasing consumer convenience, reducing illegal dumping, and ensuring consistency with the State's overall approach to waste management. Further, when it established goals for mattress recycling, CalRecycle was faced with poor quality data and thus set its goals based only on the recycling activity of the Mattress Council's contracted recyclers. As a result, the goals do not reflect all mattress waste management statewide. Further, CalRecycle has not taken adequate action to ensure mattress retailers comply with the requirements of the recycling act. CalRecycle identified violations in 74 percent of the 285 retailer, renovator, and manufacturer inspections for which it made compliance determinations during the period we reviewed, however it has not levied penalties against any violators. For five retailer inspection cases we reviewed, we determined CalRecycle could have pursued combined penalties as high as \$2.8 million if it pursued the maximum penalty for intentional, knowing, or reckless violations.

The Mattress Council has amassed excessive reserve funding. As of December 2017, the Mattress Council had over \$42 million in unrestricted net assets. State law intends that the Mattress Council operate the program over a multiyear period in a prudent and responsible manner. However, we determined that the amount of reserve funding the Mattress Council has accumulated is significantly higher than necessary to meet its stated reasons for needing a reserve.

Further, the Mattress Council has opportunities to increase consumer convenience and should establish measures of success in the areas of consumer awareness and research into new technologies. Without such

consumer awareness and research into new technologies. Without such measures, the Mattress Council cannot show that its spending in those areas has been effective and sufficient.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report detailing our review of the health and safety of correctional staff who were subject to a particular type of assault at three correctional facilities we visited—the California Department of Corrections and Rehabilitation's California Institute for Men (CIM), the Los Angeles County Sheriff's Department's Men's Central Jail (Men's Central), and the Alameda County Sheriff's Office's Santa Rita Jail (Santa Rita). This assault, known as a gassing attack, involves an inmate throwing bodily fluids at correctional staff. These attacks can expose the victim to a communicable disease and cause psychological trauma. Inmates convicted of a gassing attack can receive increases of two to four years to their current sentences. This report concludes that the three correctional facilities we visited should improve their processes to ensure that they provide all available aftercare to victims of gassing attacks, investigate such attacks more quickly and thoroughly, and better prevent and respond to gassing attacks.

The three correctional facilities did not adequately inform victims immediately following the gassing attacks of aftercare services, such as medical and counseling services. Further, these three correctional facilities did not consistently document that they advised victims of their right to request that the inmate who committed the gassing attack be tested for a communicable disease. In fact, CIM and Santa Rita were aware in some cases that inmates were infected with a communicable disease at the time of gassing attacks that occurred in 2017, but they failed to notify the victims of the exposure risk until we made inquiries

in August 2018.

Because the three correctional facilities did not consistently investigate gassing attacks in a thorough and timely manner, only 31 percent of gassing attacks at these facilities from 2015 through 2017 resulted in inmate convictions. In fact, district attorneys declined to prosecute four of the 45 cases we reviewed because the three correctional facilities did not collect sufficient physical evidence of the crime—such as the container the inmate used to throw the bodily fluids or the victim's uniform. Additionally, the three correctional facilities did

not refer cases for prosecution in a timely manner: Men's Central and CIM unnecessarily extended their investigations of gassing attacks and took an average of seven months and three months, respectively, while Santa Rita did not refer all of the cases we reviewed for prosecution. CIM and Santa Rita often did not impose discipline on inmates, such as the loss of privileges or sentence reduction credits, to deter them from committing future gassing attacks. Finally, the three correctional facilities did not provide officers sufficient training about how to respond to gassing attacks.

Members of the Assembly: As required by the Health and Safety Code sections 53533 and 53545, the California State Auditor presents its fifth audit in a series concerning the Housing and Emergency Shelter Trust Fund Acts of 2002 and 2006. This report concludes that the California Department of Housing and Community Development's (HCD) oversight of housing bond funds remains inconsistent and that HCD has failed to follow through on half of our recommendations from previous reports. We found problems related to how HCD is monitoring some bond programs, whether its housing bond database can perform key functions, and how it is ensuring that it does not exceed administrative spending limits.

Although HCD generally performed adequate monitoring of the four loan-based multifamily housing programs we reviewed, it has inadequately monitored some of its grant programs. Specifically, we found continuing problems with HCD's oversight of two of its grant-based programs, totaling more than \$610 million of housing bond funds, which we also noted in our previous housing bond audit reports. For these two programs, HCD has failed to obtain half of the required performance reports detailing how the recipients are using the money to help target populations, and it also failed for one of those programs to perform on-site visits to verify whether those recipients, such as local governments, are providing assistance only to those who qualify.

In addition, despite years of continued development, HCD cannot effectively use its centralized database system to monitor program work for all of its housing bond programs, as intended. As a result, HCD management is limited in its ability to verify that staff are receiving and monitoring required reporting documents in certain programs and cannot always assure the public that the bond funds are reaching the recipients intended in state law.

Moreover, HCD risks exceeding some statutory administrative spending limits. According to HCD, it has exceeded the 5 percent statutory administrative spending limit for at least two of its programs and estimates it will exceed the limit in another before it can fully complete its monitoring obligations. By exceeding those limits, HCD could potentially violate state law and may be unable to monitor recipients as required. Further, HCD management lacks a long-term plan for addressing its administrative spending overages.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report concerning the Tulare Local Healthcare District (district) and its oversight of the Tulare Regional Medical Center (medical center) and Healthcare Conglomerate Associates (HCCA). This report concludes that poor decisions by the district's previous board of directors (previous board) contributed to the closure of the medical center, and that licensing issues may delay its reopening.

In September 2017, after nearly four years of medical center management by HCCA, the district filed for bankruptcy and in October 2017 voted to suspend the medical center's license, and the medical center closed. The previous board did not act in the best interest of the district and the community it serves when it selected HCCA to manage the medical center in 2013. The documentation shows that the previous board selected HCCA against the advice of the consulting firm it had engaged to assist in the selection process and evidence that HCCA might not be the most qualified. The same board also negotiated contract terms with HCCA that were expensive and unfavorable, including a monthly management fee of \$225,000 or \$2.7 million a year, and provisions to become the exclusive employer of the medical center personnel, which required the district to lease the employees at a cost of 130 percent of their salaries and wages. This provision resulted in HCCA earning an additional \$2.5 million in fiscal year 2015–16. Operating revenue fell under HCCA management, caused in part by the previous board's removal of the medical center's medical executive committee—the body that governs the medical staff—and the subsequent reduction in the number of physicians choosing not to renew their privileges or resigning from the medical center, and an accompanying reduction in patient service revenue. The district's cash position also decreased under HCCA as it failed to pay vendors that provided billing services and to collect on services billed.

The district plans to reopen the medical center in mid-October 2018. Its new board of directors contracted with an interim management

consultant in November 2017 to work toward the reopening. Additionally, in September 2018, the district signed a management services agreement with a new affiliate partner to manage the medical center. Although the district has made progress toward reopening the medical center, it faces licensing issues that make it unclear whether the medical center will reopen in mid-October as planned. Finally, the district could have been more effective in its oversight of its use of \$85 million in bond proceeds for its expansion of the medical center.

Members of the Assembly: As required by Government Code section 8543 et seq., the California State Auditor (State Auditor) presents this audit report concerning the review of the State of California's internal controls and compliance with federal laws and regulations for the year ended June 30, 2017. The State Auditor contracted with Macias Gini & O'Connell LLP (MGO) to perform this audit for fiscal year 2016–17. This report supersedes Report 2017–002 originally published on March 28, 2018. This report includes two additional federal programs that were not included in the original report.

This new report concludes that the State did not materially comply with certain requirements for six of the 14 federal programs or clusters of programs (federal programs) MGO audited. Additionally, although MGO concluded that the State materially complied with requirements for the remaining federal programs it audited, MGO reported various instances of noncompliance relating to those programs. Further, the State continues to experience certain deficiencies in its accounting and administrative practices that affect its internal controls over compliance with federal requirements. Deficiencies in the State's internal control system could adversely affect its ability to administer federal programs in compliance with applicable requirements.

Members of the Assembly: This report presents the results of our high risk audit concerning \$4 billion in questionable California Medical Assistance Program (Medi-Cal) payments that the Department of Health Care Services (Health Care Services) made from 2014 through 2017 because it failed to ensure that counties resolved discrepancies between the state and county Medi-Cal eligibility systems. Counties are generally responsible for determining Medi-Cal eligibility and for recording this information in their eligibility systems, which then transmit the beneficiaries' information and Medi-Cal eligibility to the State's eligibility system. Health Care Services uses the information from the State's eligibility system to determine the amount that it pays for Medi-Cal beneficiaries. Although Health Care Services has established a process for notifying counties of beneficiary records that require follow-up, gaps in this process allowed the problems we identified to persist.

Our statewide comparison of Medi-Cal beneficiary eligibility data identified pervasive discrepancies between the state and county systems. Specifically, our analysis of 10.7 million Medi-Cal beneficiary records from December 2017 revealed more than 453,000 beneficiaries marked as eligible in the State's eligibility system although they were not listed as eligible in the counties' eligibility systems for at least three months. Upon examining the data for these beneficiaries from 2014 through 2017, we found that 57 percent of these discrepancies had persisted for more than two years. Many of these discrepancies resulted from Health Care Services failing to ensure that counties had evaluated the Medi-Cal eligibility of beneficiaries transitioning from other programs. One reason counties failed to complete those evaluations promptly was because of the implementation of the federal Patient Protection and Affordable Care Act which created a backlog of Medi-Cal applications and eligibility redeterminations.

In addition to questionable payments, we identified more than 54,000 individuals who were not recorded as eligible for Medi-Cal in Health Care Services' system, even though the counties' records indicated that they were eligible. Because health care providers use Health Care Services' records to authorize care for beneficiaries, eligible individuals may encounter hardship when their eligibility status is not accurately reflected in Health Care Services' records. Further, there may be additional data discrepancies related to people who qualify for Medi-Cal benefits through other entitlement programs.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the California State Auditor presents this audit report regarding the California High-Speed Rail Authority's (Authority) contracting and cost control practices. This report concludes that the Authority's flawed decision making regarding the start of high-speed rail system construction in the Central Valley and its ongoing poor contract management for a wide range of high-value contracts have contributed to billions of dollars in cost overruns for completing the system.

The Authority began construction in the Central Valley in October 2013 despite being aware of the risks associated with beginning construction early—the fact that the Authority had not acquired sufficient land for building, had not determined how it would relocate utility systems, and had not obtained agreements with external stakeholders. These unmitigated risks have contributed to \$600 million in costs overruns thus far for the three active Central Valley construction projects, with another \$1.6 billion in additional costs needed to complete the projects. The Authority has cited the terms of a 2010 federal grant—which originally required construction to be complete by 2017—as the primary factor in its decision to begin construction when it did. However, we determined that even with a grant deadline extension until December 2022, the Authority could miss the new deadline unless Central Valley construction progresses twice as fast as it has to date. Missing the deadline could expose the State to the risk of having to pay back as much as \$3.5 billion in federal funds.

The Authority has partially offset Central Valley cost overruns, as well as those projected elsewhere in the system, by planning to share existing rail infrastructure where possible. However, the Authority acknowledges that it has identified every feasible option to do so and therefore cannot continue to use this approach to offset costs. Moreover, despite its challenging financial situation, we determined that the Authority has failed to implement sound contract management practices. As a result, it cannot demonstrate that the large amounts it has spent on its contracts have been necessary or appropriate.
