SENATE CONCURRENT RESOLUTION NO. 1—Relative to the adoption of the Joint Rules of the Senate and Assembly for the 2003–04 Regular Session.

INTRODUCTION OF ASSEMBLY BILLS

ASSEMBLY BILL NO. 57—**Bates**. An act to amend Section 11055 of the Health and Safety Code, relating to controlled substances.

ASSEMBLY BILL NO. 59—**Dymally**. An act to add Chapter 4.5 (commencing with Section 8305) to Division 1 of Title 2 of the Government Code, relating to state history and culture.

ASSEMBLY BILL NO. 63—**Cogdill and Garcia**. An act to add and repeal Sections 17053.18 and 23638 of the Revenue and Taxation Code, relating to taxation, to take effect immediately, tax levy.
