INTRODUCTION OF ASSEMBLY BILLS

The following bills were introduced:

ASSEMBLY BILL NO. 86—McClintock. An act to add Chapter 8.2 (commencing with Section 11820) to Part 1 of Division 3 of Title 2 of the Government Code, relating to state government, and making an appropriation therefor.

ASSEMBLY BILL NO. 87—Floyd. An act to add Section 123302 to the Health and Safety Code, relating to supplemental food programs.

ASSEMBLY BILL NO. 88—Thomson (Principal Senate coauthor: Perata) Alquist, Aroner, Cardoza, Davis, Hertzberg, Knox, Kuehl, Lowenthal, Machado, Mazzoni, Migden, Papan, Scott, Shelley, Steinberg, Strom-Martin, Villaraigosa, Washington, Wayne, and Wright (Senators Alpert, Chesbro, Ortiz, Rainey, and Vasconcellos, coauthors). An act to add Section 1374.72 to the Health and Safety Code, and to add Section 10144.5 to the Insurance Code, relating to health care coverage.

ASSEMBLY BILL NO. 89—Cedillo. An act to amend Section 830.7 of the Penal Code, relating to arrest.

ASSEMBLY BILL NO. 90—Runner. An act to amend Sections 48000 and 48010 of the Education Code, relating to pupils.

ASSEMBLY BILL NO. 91—Hertzberg. An act to amend Section 3540.1 of the Government Code, relating to public school employees.

ASSEMBLY BILL NO. 92—Floyd. An act to add Sections 73.5, 73.6, and 73.7 to the Military and Veterans Code, relating to veterans.

ASSEMBLY BILL NO. 93—Cedillo. An act to amend Section 14012 of, and to add Section 14005.25 to, the Welfare and Institutions Code, relating to health.

ASSEMBLY BILL NO. 94—Cedillo. An act to amend Sections 71000 and 71003 of the Education Code, relating to the California Community Colleges.

ASSEMBLY BILL NO. 95—Cunneen. An act to add Chapter 18 (commencing with Section 11625) to Part 7 of the Education Code, relating to remedial instruction.

ASSEMBLY BILL NO. 96—Shelley. An act to amend Section 1175 of the Labor Code, relating to wages and hours.
