**ASSEMBLY BILL NO. 66**—Chesbro (Principal coauthor: Galgiani) (Principal coauthors: Senators Rubio and Volk) (Coauthors: Bradford, Monning, V. An act to amend Section 10752.2 of the Revenue and Taxation Code, relating to taxation, making an appropriation therefor, and declaring the urgency thereof, to take effect immediately.
