INTRODUCTION OF ASSEMBLY BILLS

ASSEMBLY BILL NO. 68—Waldron. An act to amend Section 14000 of the Welfare and Institutions Code, relating to Medi-Cal.

ASSEMBLY BILL NO. 69—Rodriguez. An act relating to peace officers.

ASSEMBLY BILL NO. 70—Waldron. An act to amend Section 14611 of the Welfare and Institutions Code, relating to Medi-Cal.

ASSEMBLY BILL NO. 71—Rodriguez. An act to add Section 13022.5 to the Penal Code, relating to criminal justice.

ASSEMBLY BILL NO. 72—Bonta and Atkins. An act to add Article 5.5 (commencing with Section 14184) to Chapter 7 of Part 3 of Division 9 of the Welfare and Institutions Code, relating to Medi-Cal, and declaring the urgency thereof, to take effect immediately.

ASSEMBLY BILL NO. 73—Waldron. An act to add Section 14133.06 to the Welfare and Institutions Code, relating to Medi-Cal.
