ASSEMBLY BILL NO. 100—Thomson. An act to amend Sections 12693, 12693.02, 12693.12, and 12693.70 of, and to amend and renumber Section 12963.96 of, the Insurance Code, relating to health care, and making an appropriation therefor.

ASSEMBLY BILL NO. 101—Leach. An act to add Chapter 14.5 (commencing with Section 52990 to Part 28 of the Education Code, relating to remedial instruction.
