**PRAYER**

Upon invitation of Speaker pro Tempore Lowenthal, the following prayer was offered by Guest Chaplain Rabbi Mona Alfi, of the Congregation B'nai Israel:

Good afternoon, my name is Mona Alfi, and I have the privilege of serving as the Rabbi of Congregation B'nai Israel, the oldest synagogue not only in Sacramento, but in the great state of California. My congregation was founded during the Gold Rush just down the street from where we stand today. While Sacramento was home to California's first synagogue, by 1861, there were Jewish communities throughout the state, from San Diego to Shasta. And today, you would be hard pressed to find a part of California where there is not a Jewish community.

The Eastern European Jews who came to America at the turn of the 20th century called the US a "Goldene Medina" which is Yiddish for Golden Land, or land of opportunity, freedom and prosperity. But for millions of American Jews, it has been the Golden State that has shown itself to be *our* Golden Medina.

Because here, we all have the freedom to make our dreams a reality, from the Jewish immigrant who built an empire from selling blue jeans to the gold miners, to the dreamers who told stories on celluloid, the scientists who work in aerospace, the inventors who create the future in Silicon Valley, and the human rights activists who have fought for a more just society, as well as the myriad of teachers, farmers, social workers, attorneys, medical professionals and public servants, who from the beginning of our State to this day, have contributed to what makes California special.

Because here, we welcome people from around the world, we recognize that every community has something to share with the rest of us, every person is a potential blessing.

We praise the Creator of all humanity, the One who implants within each and every one of us a spark of holiness. We ask for God's blessing on our State, and all who live here. May California continue to be a Goldene Medina, a land of opportunity, freedom and prosperity for all who seek to call California their home.—AMEN.
