I, GRAY DAVIS, Governor of the State of California, by virtue of the power and authority vested in me by Section 3(b) Article IV of the Constitution of the State of California, do hereby convene the Legislature of the State of California to meet in extraordinary session at Sacramento, California, on the 19th day of January, 1999, at a time appointed by each house of the Legislature of said day for the following purpose and to legislate upon the following subjects:

1. To consider and act upon legislation to improve the levels of reading achievement among students in the public schools.
2. To consider and act upon legislation to improve the quality of the teaching profession and the quality of school principals in the public schools.
3. To consider and act upon legislation to create an accountability system in the public schools.
