ASSEMBLY BILL NO. 113—Oller and Ashburn. An act to add Section 17021 to the Welfare and Institutions Code, relating to public social services.

ASSEMBLY BILL NO. 114—Battin. An act to add Section 23405.4 to the Business and Professions Code, relating to alcoholic beverages.

ASSEMBLY BILL NO. 115—Havice (Principal coauthor: Hertzberg) (Senator Peace, coauthor). An act to amend Section 667.5 of the Penal Code, relating to sentencing.

ASSEMBLY BILL NO. 116—Runner (Principal Senate coauthor: Knight). An act to add Section 13275 to the Water Code, relating to waste.

ASSEMBLY BILL NO. 117—Escutia. An act to add Section 42318 to the Health and Safety Code, relating to air pollution.

ASSEMBLY BILL NO. 118—Cardenas. An act to add Section 11019.7 to the Government Code, relating to state agencies.

ASSEMBLY CONSTITUTIONAL AMENDMENT NO.6—Thompson. A resolution to propose to the people of the State of California an amendment to the Constitution of the State, by adding Section 20 to Article XVI thereof, relating to governmental finance.

ASSEMBLY CONSTITUTIONAL AMENDMENT NO. 7—Escutia. A resolution to propose to the people of the State of California an amendment to the Constitution of the State, by amending Section 1 of Article XIIIA thereof, and by amending Section 18 of Article XVI thereof, relating to school facilities financing.
