#### Larry Margolis, top aide to ex-Speaker Unruh, dies

Larry Margolis, a tough-minded public policy expert who once served as the powerful top aide to former Assembly Speaker Jesse Unruh, died Saturday at Sutter General Hospital.

He was 73.

The exact cause of death wasn't immediately known, his wife, Selma, said Monday.

Respected by some, feared by others, Margolis wielded so much power while serving under Unruh from 1961 to 1965 that he was sometimes referred to as "the 81st member" of the 80-member state Assembly.

Some even perceived him as "an evil genius," Margolis conceded in a 1980 interview.

"There are people who look on me as an evil genius, someone tied into mysterious forces, linked to secret political machinations," he said.

But Capitol insiders, those who understood the process, recognized that Margolis was, in the words of one college government professor, an "idealistic reformer."

"Legislators immediately perceived the trust in which Unruh held him and feared or respected him for it," Lou Cannon wrote in "Ronnie and Jesse," a dual biography of Ronald Reagan and Jesse Unruh.

Along with helping create the Unruh Civil Rights Act, one of his greatest legacies was turning the legislative staff into a professional cadre of policy experts independent of the executive branch, said Sherry Bebitch Jeffe, senior associate at the Center for Politics and Economics at Claremont Graduate School.

In accomplishing these goals, Margolis and Unruh were so compatible in their thinking that "one could begin a sentence and the other would finish it," Jeff said.

But clearly, Larry was more than the alter ego of Jess Unruh," she said, "He was able to prod Jess, to push him intellectually. Jess was the upfront politician, while Larry was more the behind-the-scenes thinker and strategist."

But during his tenure as Unruh's chief assistant, Margolis assembled enough power to establish a sizable number of political enemies. Coupled with Unruh's aspirations to become governor, former Assembly staffers said, Margolis' clout became a threat to his boss' speakership, and he left the job in 1965.

After leaving Unruh's staff, he did a variety of things, including serving as a public policy consultant and visiting lecturer at Stanford University, the University of Kansas and the University of Missouri.

From 1967 until 1978, he was executive director of the Citizens Conference of State Legislatures, later known as Legis 50/The Center for Legislative Improvement.

Most recently, he helped found Preventive Dental Systems Inc., a non-profit health maintenance organization to provide dental care for low-income families. In 1995, he was a consultant to the Republic of Georgia's parliament, which was writing a constitution in the wake of the dissolution of the Soviet Union.

Margolis said he grew up in a poor, dysfunctional home. He and his sister ran away when he was 12 and he spent part of his teenage years in a charity-sponsored institution for the children of broken families.

Talking about the similarities between him and Unruh in a 1989 oral history interview, Margolis said:

"We came from poor families, outsider families, families that were not in the mainstream. . . . We were scramblers, street-fighters, people who didn't belong to the country club set, people who had to fight for everything we got, didn't have any helpers, no father who paved the way or set us up in business."

Like Unruh, he was a World War II veteran who attended college on the GI Bill. Margolis graduated from UCLA in 1951 with a bachelor's degree in political science. He and Unruh became acquainted through Democratic Party activities in Los Angeles.

"He was kind of an intellectual and moral giant in terms of what he understood about state government," said Jeff Lustig, government professor at California State University, Sacramento. "He had a moral vision of what he thought government ought to be—not utopian, but kind of what I call a higher realism."

Mr. Margolis was an "idealistic reformer," Lustig said.

Steve Thompson, a former Assembly staffer and now vice president of the California Medical Association, described Margolis as an idealist "who had a very strong belief that government's role was to make the world a better place for most people. . . . But he did create a lot of enemies."

Margolis is survived by his wife of 40 years, Selma Portugal Margolis of Sacramento; a son, Geoffrey Margolis of Sacramento; daughters Andrea Margolis of Cambridge, Mass., and Melinda Margolis of Las Vegas; and a sister, Shirley Luevano of Calabasas, Los Angeles County.

Services are pending.
