**INTRODUCTION AND FIRST READING OF ASSEMBLY BILLS**

The following bills were introduced and read the first time:

**ASSEMBLY BILL NO. 148—Frusetta.** An act to add and repeal Sections 17053.56 and 23656 of the Revenue and Taxation Code, relating to taxation, to take effect immediately, tax levy.

**ASSEMBLY BILL NO. 149—Runner.** An act to amend Sections 241 and 243 of the Penal Code, relating to crimes.

**ASSEMBLY BILL NO. 150—Alby.** An act to amend Section 656 of the Unemployment Insurance Code, relating to unemployment compensation.

**ASSEMBLY BILL NO. 151—Baldwin.** An act to amend Section 52126 of the Education Code, relating to class size reduction.

**ASSEMBLY BILL NO. 152—Morrow.** An act to amend Sections 679.02 and 3043.2 of, and to add Sections 1191.16 and 3043.25 to, the Penal Code, relating to victim’s rights.

**ASSEMBLY BILL NO. 153—Baldwin.** An act to add Section 53077.5 to the Government Code, and to amend Section 5353 of the Public Utilities Code, relating to youth-serving organizations.

**ASSEMBLY BILL NO. 154—Aguiar.** An act to amend Sections 191.5, 192, 192.5, 193, 193.5, and 193.7 of the Penal Code, and to amend Sections 13350, 13350.5, and 13954 of the Vehicle Code, relating to vehicles.

It was announced that the deadline to submit bill requests to the office of Legislative Counsel has been extended to January 29, 1997.
