Mary passed away . . . about four hours ago. She is, or was, my aunt. She is one of six Kansas farm girls who in the early part of this century spread out throughout the United States and made contributions that I would like to recognize, and take an extra couple of minutes of your time to tell you about Aunt Mary.

She is 98 years old. She died in Honolulu; her home is in McLean, Virginia. For at least the past twenty years she has wintered in Honolulu with another sister, and each year made a reservation to be back. This year she won't be able to do that.

Aunt Mary is one of the reasons that I am here with you today. At age ten I first visited her in Vienna, Virginia and got a chance to see our nation's Capitol. Many of you folks in Orange County, my colleagues, have heard many stories about Aunt Mary. But I'll share one with you that shows how things change over time.

She arrived in Washington, D.C., in 1917, took a room in a boarding house, met some people, and started at George Washington University. On Thanksgiving Day in 1917, she and another woman from the boarding house took a trolley down to Pennsylvania Avenue, got out across from the White House, walked across the lawn, and knocked on the front door. It was answered by a butler. They each presented their cards, because that's what proper ladies of the time would do, and asked if the President were available. Now, because it was Thanksgiving, the butler informed them that he was

out, and invited them in for tea and cookies. When they left, they noticed the sheep and goats eating the grass on the lawn because that's the way President Woodrow Wilson wanted to conserve costs during the war years.

Aunt Mary had many stories like this for many of my cousins and me who visited her over time. She did say to me, because she had over forty years of government service, that someday, "Bill, you must serve your country." . . . and that's what I am trying to do.
