Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the Tahoe Regional Planning Agency (TRPA). Our review focused on TRPA's proposed environmental improvement program and on whether TRPA's permitting and regulatory activities and streamlining efforts are effective and efficient. This report concludes that while TRPA's shift in focus to facilitating environmental improvement projects appears appropriate, it is premature to conclude on the effectiveness of TRPA's actions. Further, TRPA has taken action to streamline its regulatory activities and more effectively use its staff. However, TRPA can take additional steps to improve its regulatory efforts.

Doctor John Montgomery, one of Delano's most prominent physicians, died the morning of February 11 at age 86.

Doctor Montgomery served the community of Delano for 51 years, and continued in his duties until this past Christmas. He never officially retired from his profession.

Doctor Montgomery was the model of a country physician, seeing an average of twenty people a day and caring for all types of patients. He never refused a patient for lack of money, and was known on occasion to accept fruit or produce as his payment.

Doctor Montgomery established the Delano Community Hospital, where he served as the first Chief of Staff, performed the first major surgery, and delivered the first set of twins.

There is an ongoing joke that Doctor Montgomery delivered most of the people in Delano. He is the person most responsible for bringing new life to the town.

The California Medical Association awarded Doctor Montgomery their 1991 Frederick K.M. Plessner award as the California physician best exemplifying the ethics and practice of a rural practitioner. A Delano street bears his name and the obstetrics wing at Delano Regional Medical Center is named in honor of him and his wife. The Delano Chamber of Commerce named him "Man of the Year" in 1960 and he received the Kern County Award of Merit for Community Service.

Doctor Montgomery was active in all areas of his community. He was one of the Delano High football program's biggest boosters, donating his time as team doctor and helping raise over 36 thousand dollars for new band uniforms. He was active in many civic organizations, including fifty years with the Delano Lion's Club, where he formerly served as president.

Doctor Montgomery's son Robert put it best when he said "He really loved the people of Delano. He was a man who was living his profession and his hobby. It is what he loved to do."

Doctor Montgomery exemplifies the rural spirit of Delano. He will be missed by the thousands of people he helped.
