Dear Colleagues: Government Code Section 8956, adopted as part of the legislation enacting the Ethics in Government Act of 1990 (Ch. 84, Stats. 1990) *requires* that each Member of the Legislature attend an orientation regarding the statutes and regulations governing official conduct. This must occur at least once each biennial session.

This session, the Rules Committee and the Ethics Committee have determined that the relevant orientation may best be presented in a two-part training session. This will allow for more focused discussion and an opportunity for questions. The first component of the training will be held on Tuesday, February 25, 1997, from 4:30 to 6:30 p.m. at the Auditorium on the first floor of the Secretary of State's Building at the corner of 11th and O Streets (across from Posey's). To reach this location, exit the South Entrance of the Capitol and walk south to N Street, cross N Street and continue south on 11th Street until you cross O Street. The building will be on the corner on the right.

The content of the presentation is most topical at this time. Your Annual Statement of Economic Interests is due to be filed no later than March 3, 1997. The discussion will focus on the requirements for completing your financial disclosure statement and the related topics of restrictions on gifts and the prohibition on honoraria.

The orientation will be presented by Robert Leidigh and Diane Fishburn from the law firm of Olson, Hagel, Fong, Leidigh, Waters and Fishburn, and by Charles H. Bell, Jr., of the law firm of Bell, McAndrews and Hiltachk. Following the orientation, the speakers will respond to questions of a general nature.
