Members of the Assembly: As required by Chapter 197, Section 54(b), Statutes of 1996, the Bureau of State Audits presents its audit report concerning the Department of Alcohol and Drug Program's (department) financial procedures for allocating and disbursing funds for treatment services to counties. This report concludes that because the law allows the department to base its allocations on a variety of factors, significant disparities exist in county per capita funding levels. In addition, we found that uncertainty created by a court case and changes in state legislation involving Medi-Cal funds delayed completion of contracts between the department and counties.

Members of the Assembly: As required by Chapter 197, Section 54(e), Statutes of 1996, the Bureau of State Audits presents its audit report concerning the Department of Alcohol and Drug Program's (department) survey of alcohol and drug treatment providers.

This report concludes that an actuarial firm, William M. Mercer, Incorporated (Mercer), accurately compiled both the survey responses and other information supplied by the department. However, we found certain errors in the data provided to Mercer. Specifically, some providers did not always accurately report dates clients were discharged from treatment. We could not determine what impact, if any, these errors have on the discharge statistics reported by Mercer.

We also noted that the department did not supply Mercer with each county's procedures and timelines for allocation of funds and reimbursement costs, as required by Chapter 197, Sections 54(d)(9). Instead, the department plans to issue a supplemental report that

compiles the results of this survey item. Because the department had not completed its report by January 31, 1997, we could not validate the survey results for this item.

Members of the Assembly: As requested by the Joint Legislative Audit Committee, the Bureau of State Audits presents its audit report concerning the California State University's (CSU) role in a contractor dispute related to a project to upgrade the electrical and telecommunications infrastructure at the Fullerton Campus. This report concludes that CSU did not have a legal obligation to intervene in a dispute between a prime construction contractor and a subcontractor. However, to ensure that the project was completed, CSU did attempt to resolve the dispute. CSU met with both parties to mediate the dispute. Additionally, CSU waived liquidated damages and extended the contract deadline. Despite its attempts to resolve this dispute, CSU has acknowledged that it may be partially responsible for some of the delays which necessitated the extension of the original contract completion date. Finally, we found that CSU did not consistently enforce one of the provisions of the contract, which may have contributed to one of the items of contention in the dispute.

Members of the Assembly: As required by Chapter 16 of the Statutes of 1990, the Bureau of State Audits presents its audit report concerning "California Transportation Commission and Department of Transportation: The State's Use of Transportation Funds Generated by the 1989 Transportation Blueprint Legislation." This report concludes that the State allocated and expended

transportation funds in accordance with statutory requirements. It also concludes that revenues anticipated by the legislation are only 40 percent and expenditures only 47 percent of the legislative estimate after six years of the ten-year program. The report also concludes that the department allowed \$667 million in spending authority to expire primarily, according to the department, because of savings between estimated and actual project costs. Additionally, redirections of blueprint revenue totaled approximately \$716 million. The department stated that these redirections were diverted to seismic retrofit or, pursuant to legislation, primarily to the General Fund.
