POLICY FOR USE OF THE

INTERIOR OF THE STATE CAPITOL FOR EVENTS

(Adopted by the Committee on Joint Rules on March 20, 1997)

The first and second floors of the West Wing of the California State Capitol will be restricted to use by the Governor, Lieutenant Governor, President pro Tempore of the Senate, Speaker of the Assembly and scheduled through the Joint Committee on Rules.

The West Wing of the Capitol basement may be used for functions and will require a letter of request from a sponsoring member of the Legislature or the executive branch and approval from the Joint Rules Committee.

If food or drinks are being served in the basement, the event will be restricted to the dining area. As a general rule, no food or drinks will be allowed in the basement Rotunda areas. (Attachment 1—Rules and Regulations)

For every approved event in the Capitol basement, there will be a use fee of \$750 dollars, a \$500 refundable cleaning/damage deposit, and a charge for an event monitor to enforce the rules adopted for use of the Capitol. The presence and associated fee for the California Highway Patrol should be limited to specific requests by the sponsor and the users. (Attachment 2—Schedule of Charges)

Catering guidelines should be adopted and monitored to ensure compliance. (Attachment 3—Catering Guidelines)

Sponsorship responsibility should be clearly delineated so that the function will have a single point of contact and that the sponsor will be aware of all issues surrounding the event. (Attachment 4—Sponsorship Responsibility)

CALIFORNIA STATE CAPITOL BASEMENT ROTUNDA AND DINING AREAS

RULES AND REGULATIONS

1. Groups, organizations or individuals may request the use of the Capitol Basement Rotunda and Dining areas for receptions, retirement dinners or other social functions through a sponsoring Member of the Legislature who must direct the request to the Chair of the Joint Rules Committee.

All functions occurring in the Capitol Basement Rotunda and Dining areas must have prior written approval from the Chief Administrative Officer of the Joint Rules Committee.

2. Eurest Dining Services is the food service contractor for the Capitol Basement Dining facility. They provide a full range of catering services and the restaurant manager can be reached at (916) 443-7314.

However, each party to this agreement may choose a caterer other than Eurest Dining Services; but access will be limited to the Basement Rotunda and Dining areas only. **No kitchen** facilities are available to outside caterers.

- 3. Use of the Dining area during Eurest's business hours (Monday through Friday, 7:00 a.m.-4:00 p.m.) for a group breakfast or luncheon, requires approval from both the Joint Rules Committee and Eurest Dining Services. Caterers other than Eurest may *not* be used for the Capitol Basement Dining area during Eurest's regular business hours.
- 4. Each party to this agreement, using the Capitol Basement Rotunda and Dining areas for an approved function, shall be held responsible for clean up of all refuse attributable to the function. All tables and chairs must be clean and returned to their original positions in the dining area. Do *not* drag furniture (tables, chairs, etc.) across the floors.
- 5. Each party to this agreement, using the Capitol Basement Rotunda and Dining areas, shall be held responsible for any loss or damage to State property, including structural (walls), which occurs during an approved function.
- 6. Each party to this agreement, using the Capitol Basement Rotunda and Dining areas must provide evidence of liability insurance providing the minimum levels of coverage, as follows:

\$100,000 bodily injury per person, per occurrence.\$300,000 bodily injury for all persons, per occurrence.\$50,000 property damage per occurrence.\$50,000 products liability per occurrence.

With a combined single limit of \$500,000 per occurrence. Furthermore, each insurance policy providing such coverage shall have a special endorsement added to the policy which provides the following:

(a) That the State of California, its officers, employees and servants are included as additional insured, but only insofar as the operations under this agreement.

- (b) That the insurer will not cancel or reduce the insured's coverage without notice to the State-Joint Rules Committee.
- (c) That the State will not be responsible for the payment of any premiums or assessments on the policy.
- 7. An event monitor, designated by the State, will be on hand at the event to ensure that all Joint Rules policies, rules and regulations are followed.
- 8. California Highway Patrol officers are on duty at all times to provide security for the State Capitol Building. They are notified of all events occurring in the Capitol Building and are readily available to defuse any confrontation or to remove any unruly event participants. The event monitor may call upon them any time he/she deems it necessary to control a situation or enforce the rules and regulations.
- 9. Excessive alcohol consumption or disorderly conduct shall, at the sole discretion of the California Highway Patrol, be grounds for expulsion of the individual participant(s) from the function or the immediate termination of the function.
- 10. The public shall not be denied access to any public area of the Capitol Building, due to an approved function, during normal hours. The Capitol Building hours are 7:00 a.m. to 6:00 p.m., Monday through Friday; and 8:30 a.m. through 5:00 p.m., Saturday and Sunday.
- 11. Individuals attending approved functions shall stay within the designated public areas of the Capitol Building and shall obey all signs displaying rules and regulations.
- 12. Nothing may be attached to the walls, floors, or ceilings of the Capitol.
- 13. State property and equipment (e.g. benches, display cases, stanchions, etc.) in the Capitol Rotunda area may *not* be moved under any circumstance.
- 14. Nothing may be placed behind any stanchions or display cases, or inside the Museum of office suites.
- 15. Do *not* stack boxes or anything else on top of State property or equipment (e.g. benches, chairs, display cases, etc.).
- 16. Tables and chairs, other than those already in the Dining area, are *not* available from the Legislature.
- 17. Food and beverages are restricted to the Basement Dining area. They are *not* permitted in the Capitol Rotunda.
- 18. Seated dining is *not* permitted in the Capitol Rotunda or hallway areas.
- 19. Lit candles or similar devices are *not* permitted at any time or anywhere in the Capitol.
- 20. Seating capacity in the Capitol Basement Dining area:

1. Non-refundable use fee: \$750.00

This fee applies to the use of the Capitol Basement Rotunda and Dining areas. Please make this check payable to: State of California.

2. Event Monitor fee: \$14.35 per hour

This fee applies to all functions in the Capitol Basement Rotunda and Dining areas, starting at set up time until the event ends. **Please make this check payable to: State of California.**

3. Refundable cleaning/damage deposit: \$500.00

This deposit will be returned only if the Capitol Basement Rotunda and Dining areas are clean and free from refuse and all furniture is returned to its proper position following the event. Also, the areas will be checked for damages. **Please make this check payable to: State of California.**

Please pay all fees and deposit with separate checks.

The use fee; event monitor fee; cleaning deposit; certificate of insurance; and signed agreement must all be received in the office of the Joint Rules Committee, State Capitol, Room 3016, Sacramento, California, 95814, **at least 15 working days prior to the approved function.**

Questions should be directed to your legislative sponsor.

USAGE OF THE CAPITOL ROTUNDA

The first and second floors of the West Wing of the California State Capitol are considered a living museum in that working offices and public museum rooms are located there. In order to preserve the historical value of the Rotunda, the first and second floors of the Rotunda will be restricted to use by the Speaker of the Assembly, the President pro Tempore of the Senate, the Governor, and the Lieutenant Governor.

The Capitol Basement Rotunda may be used for functions, but requires the sponsorship from a Member of the Legislature and approval of Joint Rules.

If food and beverages are being served, they must be restricted to the dining area. Food or beverages are *not* allowed in the Rotunda areas.

There is a use fee, an event monitor fee, a refundable cleaning/damage deposit, and required paperwork (signed agreement and proof of liability insurance) associated with using the Capitol Rotunda and Dining areas. This is part of a packet that is enclosed with the approval letter sent to the sponsoring member's office by Joint Rules.

CATERING GUIDELINES FOR THE CALIFORNIA STATE CAPITOL ROTUNDA AND BASEMENT DINING AREAS

- 1. Contact the legislative sponsor of the event, *at least 48 hours* before the event, to gain access to the loading dock.
- 2. The earliest set up may begin in the Capitol Basement Dining area for a weeknight event is 4:30 p.m. For weekend events, please contact the legislative sponsor.
- 3. An event monitor will meet you in the Capitol Basement Dining area to help direct you where to set up.
- 4. Tables and chairs are *not* available from the Legislature. Please provide your own equipment.
- 5. Food and beverages are *not* permitted in the Rotunda area.
- 6. Kitchen facilities are not available.
- 7. Carts and hand trucks are *not* available. Please provide your own equipment.
- 8. State furniture and equipment (e.g. benches, display cases, stanchions, etc.) may *not* be moved. The tables and chairs in the Basement Dining area may be moved (check with the event monitor first), but must be clean and returned to their original positions.
- 9. Tables may *not* touch any of the walls.
- 10. Do *not* attach anything to the walls, floors, or ceilings of the Capitol.
- 11. Do not drag furniture (tables, chairs, etc.) across the floor.
- 12. Do *not* stack boxes or anything else on top of State property (chairs, benches, etc.)
- 13. Do *not* put anything behind the stanchions or in the Museum rooms or office suites.
- 14. Do *not* put anything hot or steaming near the walls, murals, or portraits.
- 15. Please have all catering and rental equipment removed from the Capitol by the end of the event—in all cases, no later than 10:00 p.m.

Failure to adhere to these guidelines may result in loss of privilege to provide catering services in the Capitol Building. If you have any questions, please contact the legislative sponsor of the event.

CALIFORNIA STATE CAPITOL ROTUNDA AND BASEMENT DINING AREAS

SPONSOR'S RESPONSIBILITIES

As the sponsor of a group, organization, or individual who has been given approval to use the Capitol Basement Rotunda and Dining areas, your responsibilities are as follows:

- 1. Provide the group with the enclosed California State Capitol Basement Rotunda and Dining Areas—Rules and Regulations.
- 2. Provide the caterer with the enclosed Catering Guidelines for the California State Capitol Basement Rotunda and Areas.
- 3. Provide Joint Rules Committee with the required checks, a signed copy of the Agreement for the Use of the California State Capitol Basement Rotunda and Areas, and proof of liability insurance *at least 15 days* prior to the event.
- 4. Request loading dock access, if needed, for the caterer or delivery people through the Assembly Sergeants at (916) 445-2401 or Senate Sergeants at (916) 445-6070. Access may be denied unless this is pre-arranged prior to the event.
- 5. Submit, in writing, requests for a PA system *at least 5 days* prior to the event. NOTE: There is a fee associated with the use of the PA system, charged by the Department of General Services.
- 6. Be sure that the organization and the caterer understands that *set up may not begin until 4:30 p.m.* in the Capitol Basement Dining area and that food and beverages are *not* permitted in the Rotunda area.
- 7. There will be an event monitor in the Basement Dining area to direct the set up of the event. Please remind the event organizer and the caterer that the monitor is there to ensure that Joint Rules policies and rules and regulations are followed and their cooperation would be appreciated.
- 8. Tables and chairs, other than those already in the Basement Dining area, are not available through the Legislature. Please be sure the event organizer and the caterer are aware of this.
