Real Property Disclosures-#6281

Dear Mr. Torlakson:

### **OUESTION**

In the context of transfers of residential real property and the disclosures relating to flooding and fire hazards to be required by Section 1102.6c of the Civil Code, must those disclosures be made on either a Natural Hazard Disclosure Statement or the Local Option Real Estate Transfer Disclosure Statement, the forms of which statements are prescribed by statute, or may those disclosures also be validly made in the form of an expert report, pursuant to Section 1102.4 of the Civil Code, without the use of either statutory form?

#### **OPINION**

In the context of transfers of residential real property, the disclosures relating to flooding and fire hazards to be required by Section 1102.6c of the Civil Code must be made on either a Natural Hazard Disclosure Statement or the Local Option Real Estate Transfer Disclosure Statement to be valid. Those disclosures may not validly be made in the form of an expert report, pursuant to Section 1102.4 of the Civil Code, without the use of either statutory form.

#### **ANALYSIS**

Initially, by way of background, Article 1.5 (commencing with Section 1102 of Chapter 2 of Title 4 of Part 4 of Division 2 of the Civil Code<sup>1</sup> (hereafter Article 1.5) generally requires that in certain transfers of real property in this state, the seller or transferor of the property, and

his or her agents, must deliver to the prospective buyer or transferee a written statement known as a Real Estate Transfer Disclosure Statement.

Section 1102 provides that the requirements of Article 1.5 apply to any transfer, by sale, exchange, installment land sale contract, lease with an option to purchase, any other option to purchase, or ground lease coupled with improvements, of real property, or residential stock cooperative, improved with or consisting of not less than one nor more than four dwelling units (subd. (a), Sec. 1102). Section 1102.2 specifies exceptions to the disclosure requirements of Article 1.5.

Section 1102.6 sets forth the form of the Real Estate Transfer Disclosure Statement and requires a wide variety of disclosures regarding the subject property <sup>2</sup> including, among other things, disclosures with respect to structural defects and building additions; the appliances and other items included in the sale; environmental hazards, encroachments, and easements; flooding or drainage problems; zoning violations, deed restrictions, and homeowners' associations; and other pertinent information about the property (the complete text of Section 1102.6 is attached hereto as Schedule A).

In addition to the disclosures required by Section 1102.6, a city or county may elect to require other disclosures by sellers of property described in Section 1102, and their agents, on a form known as a Local Option Real Estate Transfer Disclosure Statement. Section 1102.6a sets forth the form of the Local Option Real Estate Transfer Disclosure Statement and provides, in part, as follows:

- "1102.6a. (a) On and after July 1, 1990, any city or county may elect to require disclosures on the form set forth in subdivision (b) in addition to those disclosures required by Section 1102.6. However, this section does not affect or limit the authority of a city or county to require disclosures on a different disclosure form in connection with transactions subject to this article pursuant to an ordinance adopted prior to July 1, 1990. Such an ordinance adopted prior to July 1, 1990, may be amended thereafter to revise the disclosure requirements of the ordinance, in the discretion of the city council or county board of supervisors.
- "(b) Disclosures required pursuant to this section pertaining to the property proposed to be transferred, shall be set forth in, and shall be made on a copy of, the following disclosure form: [the form for Section 1102.6a is attached hereto as Schedule B]
- "(c) This section does not preclude the use of addenda to the form specified in subdivision (b) to facilitate the required disclosures. This section does not preclude a city or county from using the disclosure form specified in subdivision (b) for a purpose other than that specified in this section."

Thus, in addition to the Real Estate Transfer Disclosure Statement, sellers and their agents may be required, by local ordinance, to make

additional disclosures on a Local Option Real Estate Transfer Disclosure Statement.

With this statutory framework in mind, we now turn to Section 1102.6c. Last year, Assembly Bill No. 6 of the First Extraordinary Session of the Legislature was enacted (Ch. 7, Stats. 1997, 1st Ex. Sess.; hereafter A.B. 6). This measure, among other things, added Section 1102.6c to Article 1.5 to provide as follows:

- "1102.6c. (a) This section shall apply only to any real property that is subject to one or more of the following:
- "(1) Zone A of flood insurance rate maps issued by the Federal Emergency Management Agency pursuant to the National Flood Insurance Act of 1968 (42 U.S.C. Secs. 4001 et seq.).
  - "(2) Section 8589.4 of the Government Code.
  - "(3) Section 51183.5 of the Government Code.
  - "(4) Section 2621.9 of the Public Resources Code.
  - "(5) Section 2694 of the Public Resources Code.
  - "(6) Section 4136 of the Public Resources Code.
- "(b) In addition to the disclosure required pursuant to Section 1102.6, the transferor of any real property that is subject to this section, or his or her agent, shall deliver to the prospective transferee the following natural hazard disclosure statement:

## "NATURAL HAZARD DISCLOSURE STATEMENT

"The seller and his or her agent(s) disclose the following information with the knowledge that even though this is not a warranty, prospective buyers may rely on this information in deciding whether and on what terms to purchase the subject property. Seller hereby authorizes any agent(s) representing any principal(s) in this action to provide a copy of this statement to any person or entity in connection with any actual or anticipated sale of the property.

"THE FOLLOWING ARE REPRESENTATIONS MADE BY THE SELLER AND HIS OR HER AGENT(S) BASED ON THEIR KNOWLEDGE AND MAPS DRAWN BY THE STATE.

"THIS INFORMATION IS A DISCLOSURE AND IS NOT INTENDED TO BE PART OF ANY CONTRACT BETWEEN THE BUYER AND THE SELLER.

"THIS REAL PROPERTY LIES WITHIN THE FOLLOWING HAZARDOUS AREAS(S):

"A SPECIAL FLOOD HAZARD AREA (Zone "A") designated by the Federal Emergency Management Agency.

attaches a report prepared pursuant to subdivision (c) of Section 1102.4 that verifies the property is not in the hazard zone. Nothing in this subdivision is intended to limit or abridge any existing duty of the seller or the seller's agents to exercise reasonable care in making a determination under this subdivision.

- "(d) The disclosure required pursuant to this section may be provided by the seller and seller's agent in the Local Option Real Estate Disclosure Statement provided that the Local Option Real Estate Disclosure Statement includes substantially the same information and substantially the same warning that is required by this section.
- "(e) The disclosure required pursuant to this section is only a disclosure between the seller, the seller's agents, and the buyer, and shall not be used by any other party, including, but not limited to, insurance companies, lenders, or governmental agencies, for any purpose.
- "(f) The specification of items for disclosure in this section does not limit or abridge any obligation for disclosure created by any other provision of law or that may exist in order to avoid fraud, misrepresentation, or deceit in the transfer transaction." (Emphasis added.)

Thus, Section 1102.6c, when it become operative,<sup>3</sup> will require sellers of residential real property or their agents, in addition to making other statutorily required disclosures, to disclose whether the subject property is located within a defined flood hazard area, area of potential flooding, a very high fire hazard severity zone, a wildland area that may contain substantial forest fire risks and hazards, an earthquake fault zone, or a seismic hazard zone. The question before us is whether those disclosures must be made by delivery of the Natural Hazard Disclosure Statement or Local Option Real Estate Transfer Disclosure Statement, as specified in subdivisions (b) and (d) of Section 1102.6c, or whether those disclosures may also be validly made by some other means.

To ascertain the meaning of Section 1102.6c, we begin with the language in which the statute is framed (*Leroy T. v. Workmen's Comp. Appeals Bd.*, 12 Cal. 3d 434, 438). As set forth above, subdivision (b) of Section 1102.6c states, in part, that ". . . the transferor of any real property that is subject to this section, or his or her agent, *shall* deliver to the prospective transferee the . . . natural hazard disclosure statement" (emphasis added). Subdivision (d) of Section 1102.6c then specifies a single alternative means for making the required disclosures by providing as follows:

"1102.6c \* \* \* \*

"(d) The disclosure required pursuant to this section may

be provided by the seller and seller's agent in the Local Option Real Estate Disclosure Statement provided that the Local Option Real Estate Disclosure Statement includes substantially the same information and substantially the same warning that is required by this section." (Emphasis added.)

It has been held that the word "shall" is ordinarily used by the Legislature to express a mandatory requirement (*Hogya* v. *Superior Court*, 75 Cal. App. 3d 122, 133). Additionally, under the doctrine of "expressio unius est exclusio alterius," the enumeration of things coming within a statute will preclude the inclusion by implication of other things (*Gonzales* v. *Concord Gardens Mobile Home Park, Ltd.*, 90 Cal. App. 3d 871, 874; *People* v. *Mancha*, 39 Cal. App. 3d 703, 713). Hence, by providing that the transferor his or her agent "shall" deliver the prescribed Natural Hazard Disclosure Statement, and by identifying the Local Option Real Estate Transfer Disclosure Statement as a single alternative means for making the required disclosures, it appears that the Legislature intended the use of one of those two forms to be mandatory and exclusive.<sup>4</sup>

Further, the Natural Hazard Disclosure Statement specifies that the representations contained in the statement are "made by the Seller and his or her agent(s) based on their knowledge and maps drawn by the state." (subd. (b), Sec. 1102.6c). The Natural Hazard Disclosure Statement does not contemplate that the seller and agent, or a public agency, may merely deliver copies of the maps to the transferee, but specifically requires the seller and agent to identify whether the property lies within any of the hazard areas designated on the maps. Subdivision (c) of Section 1102.6c then provides the following guidelines for sellers and their agents in the event of uncertainty:

"1102.6c. \* \* \* \*

"(c) If [the] . . . map or accompanying information is not of sufficient accuracy or scale that a reasonable person can determine if the subject real property is included in a natural hazard area, the seller or seller's agent shall mark "Yes" on the Natural Hazard Disclosure Statement. The seller or seller's agent may mark "No" on the Natural Hazard Disclosure Statement if he or she *attaches a report prepared pursuant to subdivision* (c) of Section 1102.4 that verifies the property is not in the hazard zone.

\* \* \*" (Emphasis added.)

The above-emphasized language of subdivision (c) is the only reference in Section 1102.6c to the use of reports or other information in connection with the required disclosures of that section and, clearly, the

specified report is to be provided with, and not in lieu of, the Natural Hazard Disclosure Statement.

Similarly, with respect to the Local Option Real Estate Transfer Disclosure Statement, subdivision (c) of Section 1102.6a provides:

"1102.6a \* \* \* \*

"(c) This section does not preclude the use of addenda to the form specified in subdivision (b) to facilitate the required disclosures. This section does not preclude a city or county from using the disclosure form specified in subdivision (b) for a purpose other than that specified in this section." (Emphasis added.)

Thus, this provision also appears to allow reports or other information to be used by sellers and their agents for disclosure purposes, but only if they are provided with, and not in lieu of, the Local Option Real Estate Transfer Disclosure Statement.

Accordingly, based on the provisions of Sections 1102.6c and 1102.6a, it is clear that delivery of the Natural Hazard Disclosure Statement, or its local alternative, is intended to be the exclusive means for providing the disclosures required by Section 1102.6c.

It has been suggested, however, that Section 1102.4 provides an alternative method for sellers and agents to make the disclosures specified in Section 1102.6c. That section provides as follows:

- "1102.4. (a) Neither the transferor nor any listing or selling agent shall be liable for any error, inaccuracy, or omission of any information delivered pursuant to this article if the error, inaccuracy, or omission was not within the personal knowledge of the transferor or that listing or selling agent, was based on information timely provided by public agencies or by other persons providing information as specified in subdivision (c) that is required to be disclosed pursuant to this article, and ordinary care was exercised in obtaining and transmitting it.
- "(b) The delivery of any information required to be disclosed by this article to a prospective transferee by a public agency or other person providing information required to be disclosed pursuant to this article shall be deemed to comply with the requirements of this article and shall relieve the transferor or any listing or selling agent of any further duty under this article with respect to that item of information.
- "(c) The delivery of a report or opinion prepared by a licensed engineer, land surveyor, geologist, structural pest control operator, contractor, or other expert, dealing with matters within the scope of the professional's license or expertise, shall be sufficient compliance for application of the exemption provided by subdivision (a) if the information is provided to the prospective transferee pursuant to a request therefor, whether written or oral. In responding to such a request, an expert may indicate, in writing, an understanding that the information provided will be used in fulfilling the requirements of Section 1102.6 and, if so, shall indicate the required disclosures, or parts thereof, to which the information being furnished is applicable. Where such a statement is furnished, the expert shall not be responsible for any items of

information, or parts thereof, other than those expressly set forth in the statement." (Emphasis added.) <sup>5</sup>

Subdivisions (a) and (c) of Section 1102.4 provide relief from liability for sellers and their agents for erroneous, inaccurate, or omitted information delivered to a prospective transferee if the error, inaccuracy, or omission was based on information provided by public agencies or other specified experts. Of more relevance to our present analysis, however, is subdivision (b). Under subdivision (b), if information that is otherwise required to be disclosed by the seller or the seller's agent is delivered to the transferee by a public agency or other person, that delivery constitutes compliance with the requirements of Article 1.5 and relieves the seller and the seller's agent from any further duty with respect to that item of information.

Subdivision (b) of Section 1102.4 states that it applies to "the delivery of any information required to be disclosed by this article" (emphasis added). Because Section 1102.6c is part of Article 1.5, the provisions of subdivision (b) of Section 1102.4 could apply to Section 1102.6c. Further, it has been held that, in enacting any law, the Legislature is presumed to have had knowledge of existing statutory law and judicial decisions pertaining to the subject matter of that law (see Bailey v. Superior Court, 19 Cal. 3d 970, fn. 10, at 977–978). Thus, because A.B. 6 does not create any express exception with respect to subdivision (b) of Section 1102.4, it is arguable that subdivision (b) of Section 1102.4 is intended to be applicable to, and provides an alternative means for compliance with, the disclosure requirements under Section 1102.6c. Section 1102.4 has not been interpreted by any published cases and the legislative history does not provide any guidance with respect to the intended scope of subdivision (b) of that section or its relation with other provisions of Article 1.5.

The above interpretation of subdivision (b) of Section 1102.4 would, if applied, create a conflict with the mandatory language of Section 1102.6c and the other terms of the section, discussed above. To resolve such a conflict, it is an axiom of statutory construction that a particular or specific provision will take precedence over a conflicting general provision (Sec. 1859, C.C.P.; *Agricultural Labor Relations Bd.* v. *Superior Court*, 16 Cal. 3d 392, 420; *Fleming v. Kent*, 129 Cal. App. 3d 887, 891) and a more recent statute will govern and take precedence over an earlier provision (*Fleming v. Kent*, supra, at p. 891; *Palmer v. Agee*, 87 Cal. App. 3d 377, 383). Hence, in this context, we think that the new mandate of Section 1102.6c would prevail over the more general, and older, provisions of subdivision (b) of Section 1102.4. <sup>6</sup>

In conclusion, it is our opinion that, in the context of transfers of residential real property, the disclosures relating to flooding and fire

hazards to be required by Section 1102.6c of the Civil Code must be made on either a Natural Hazard Disclosure Statement or the Local Option Real Estate Transfer Disclosure Statement to be valid. Those disclosures may not validly be made in the form of an expert report, pursuant to Section 1102.4 of the Civil Code, without the use of either statutory form.
